# TO RECORD RECOGNISED ENTITIES FOR THE COLLECTIVE REPRESENTATION OF THIRD-COUNTRY NATIONALS

## THE MINISTER FOR MIGRATION POLICY

# With regard to:

- 1. Presidential Decree 123/2016 (A' 208) 'Reestablishment and renaming of the Ministry of Administrative Reform and E-Governance, reestablishment of the Ministry of Tourism, establishment of the Ministry for Migration Policy, and the Ministry of Digital Policy Telecommunications and Media, renaming of the Ministry of Interior and Administrative Reconstruction, of the Ministry of Finance, Development and Tourism and of the Ministry of Infrastructure, Transport and Networks.'
- 2. The provisions of Article 21 par. 3 indent (c) of Presidential Decree 122/2017 (A' 149) 'Organisation of the Ministry for Migration Policy'.
- 3. Presidential Decree 22/2018 (A'37) 'Appointment of Ministers, Deputy Ministers and Vice-Ministers', in accordance with which Dimitrios Ath. Vitsas is appointed to the position of Minister for Migration Policy.

4. The need for a complete record of recognized entities for the collective representation of third-country nationals, with the purpose of initiating communication and cooperation with the Ministry aiming to: a) a more thorough update of both third-country nationals and relevant entities with regard to the activities of recognized entities for collective representation and b) the facilitation of the planning and implementation of migration policy measures and integration policies, in the framework of the National Integration Strategy.

## **Invites**

recognized entities for the collective representation of third-country nationals which are active in the Greek territory, to send details of their entities active in Greece so as to be registered by the Unit of Socio-economic Integration, of the Directorate for Social Integration.

To register it is required to supply the following details:

- (i) General information about the entity, such as: legal name, year of establishment, number of members, Tax Registration Number, nationalities served by the entity, areas of responsibility
- (ii) Contact details of the entity such as: head office address, telephone, fax, electronic mail, website, social media accounts
- (iii) Full details of the legal representative of the entity, such as: full name, citizenship, identification card number, number of residence permit, passport number
- (iv) Comments and additional information including details which contribute to an understanding of the identity or/and the particularities of the entity
- (v) Attachment of the statute and any amendments of the statute.

Information supply shall be made by completing a record form of recognized entities for the collective representation of third-country nationals, with the statute of the entity in attachment form, to the e-mail address <a href="mailto:communities@immigration.gov.gr">communities@immigration.gov.gr</a>.
