







Chart 2. Transfers to the Mainland May 2021 - May 2022 (12 months) - See Appendix Table 2

The goal of the Government is the equal and fair distribution (1%) of asylum seekers in all the regions of the country, with the exception of the first reception points. There was a general decrease in the number of residents in most regions by 60% (from 53.705 to 21.725) during the last 12 months.

Chart 5. Distribution of Asylum Seekers per Region and Accommodation scheme – See Appendix Table 4 & 5






Chart 7. Pre-Registrations of applications per Regional Office or Asylum Unit and per Region for the reference month (May 2022) – See Appendix Table 7b






Chart 8. Applications for International Protection per year. For 2022 applications are calculated till the month of reference (May) - See Appendix Table 8a




Chart 12. Aggregate Decisions issued in 1st and 2nd Instance per month - See Appendix Table 10







10. HELIOS Integration Program

- The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:
- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.
- The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration.

From 16/7/2019 until 2/6/2022 35.729 people have registered in the program, while 17.121 recognized refugees receive financial assistance for renting a house. It is worth noting that in May, 249 new leases were added to the accommodation support of the "Helios" program (regarding the period from 4/5/2022 till 2/6/2022). At the same time 7.178 beneficiaries of International Protection have been enrolled in the integration courses and 8.144 people are attending job counseling sessions.




Chart 15. Helios Enrollments – See Appendix Table 12




Chart 16. New leases (left), Receiving rental allowance (Right) - See Appendix Table 13 and 14

In May 2022 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:

- 277 forced deportations and returns of third country nationals, based on agreements of the European Union, but
- also bilateral agreements of our country.
- 269 voluntary departures through IOM.
- 115 voluntary departures of immigrants from our country to their countries of origin.
- 94 transfers to Member States of the European Union under the Dublin Regulation.
- 8 minor left with the relocation program of unaccompanied minors.
- 51 people seeking International Protection were transferred to Italy (33) and France (18) in the context of voluntarily relocation program.
- 9 Beneficiaries of International Protection moved to France (7) and Italy (2) as part of a relocation program implemented in cooperation with IOM funded by the European Commission.
- Returns under the EU Turkey Joint Declaration have not been made since March due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures, from 01/06 the requests of missions-returns of the Greek authorities have not been answered.
 - A total of 823 people left the country in May, while 1.015 arrived.




Chart 17. Returns-Departures – See Appendix Table 15




Chart 18. Arrivals of Ukrainians (May 2022) - See Appendix Table 16




Chart 19. Total Ukrainian Residents & Online pre-registrations of applications (May 2022) - See Appendix Table 17 & 18




Chart 20. Total card issues to Ukrainians for Temporary Protection per age group and gender (May 2022) - See Appendix Table 19
