

Supporting Documents for TDV Renewal Applications of Minors With Personal Appearance Before the Regional Asylum Offices/Asylum Units

A. Single-parent families and

Families where custody of a child is exercised by one parent

- 1. Application for renewal of the child's TDV
- 2. Digital photograph
- 3. <u>Only for children over the age of 15</u>: <u>Solemn declaration</u> of not having committed any offense with signature authentication of the minor child and the parent
- 4. Proof of custody by a single parent, that is to say:
- 4a) For children born before entering Greece:
 - i. Foreign public document/judgment of a foreign court (e.g. divorce, death certificate of a parent, document awarding custody), or
 - ii. Affidavit before a Justice of the Peace or a notary (for events in the country of origin),
 or
 - iii. Judgment by a Greek Court (for events outside the country of origin)
- 4b) For children born in Greece: Recent copy of birth certificate, father unknown.
- 4c) For children born outside of Greece after entering the country: Recent copy of birth certificate, father unknown, from a competent authority of the country of birth that meets the requirements of a foreign document (APOSTILLE).
- 5. Solemn declaration of parental consent with signature authentication
 - In exceptional circumstances, in case of <u>inability of the parent to appear for reasons</u>
 of force majeure and if the child is over 15 years old: Written authorization from the
 Juvenile/Public Prosecutor



B. Unaccompanied minors

I. Under the age of 15

- 1. <u>Application</u> for renewal of TDV <u>signed</u> by the appointed guardian and with personal presence of the minor
- 2. Digital photograph

II. Over the age of 15

- 1. Application for renewal of TDV signed by the minor
- 2. Digital photograph
- 3. <u>Solemn declaration</u> of not having committed any offense with signature authentication of the minor
- *In case of proven <u>inability of personal presence due to disability or serious illness, the application is lodged by a representative</u> as follows:
- 1. <u>Application</u> for renewal of TDV <u>signed</u> by [the minor with signature authentication] / [by the specially authorized representative]
- 2. Digital photograph
- 3. <u>Solemn declaration</u> of not having committed any offense with signature authentication of the minor
- 4. Special authorization to the representative with signature authentication
- 5. Medical documents from a public hospital



C. One of the parents is outside of Greece and has custody of the child

- 1. Application for renewal of the child's TDV signed by a parent in Greece
- 2. Digital photograph
- 3. <u>Only for children over the age of 15</u>: <u>Solemn declaration</u> of not having committed any offense with signature authentication of the minor and the parent who is in Greece
- 4. Solemn declaration of consent of the parent who is outside of Greece with signature authentication from a competent Greek consular authority
- 5. <u>Solemn declaration of consent</u> of the parent who is in Greece with signature authentication
 - In exceptional circumstances, in case of <u>inability of the parent who is in Greece to appear for reasons of force majeure and if the child is over 15 years old</u>: Written authorization from the Juvenile/Public Prosecutor
