


Chart 1. Arrivals May 2022 – May 2023 – See Appendix Table 1




Chart 2. Transfers of asylum seekers from the islands to the mainland May 2022 – May 2023 - See Appendix Table 2

The residents in the islands increased by 98% in May 2023 compared to the corresponding month of 2022.




Chart 3. Island Residents in total May 2022 - May 2023 - See Appendix Table 3




Chart 4. Progress of Residents through time - See Appendix Table 6




Chart 5. Distribution of Asylum Seekers per Region and Accommodation scheme – See Appendix Table 4 & 5






Chart 7. Pre-Registrations of applications per Regional Office or Asylum Unit and per Region for the reference month (May 2023) – See Appendix Table 7b




Chart 8. Applications for International Protection per year. For 2023 applications are calculated till the month of reference (May) - See Appendix Table 8a






Chart 10. Applications for International Protection per month with distinction between first time and subsequent (May 2022 - May 2023) - See Appendix Table 8c

# 6d. Applications for International Protection per nationality, gender and age group




Chart 11. Applications for International Protection 5-months 2023 per Nationality (Top 10 Nationalities and distribution per continent) - See Appendix Table 8d





Chart 12. Applications for International Protection 5-months 2023 per gender and age group - See Appendix Table 8e






Chart 15. 2<sup>nd</sup> Instance Decisions per month and type for 2023 and for the month of reference (May 2023). - See Appendix Table 9b




Chart 16. Appeals that have been lodged the 5-months of 2023 per location and quarter – See Appendix Table 10a






Chart 19. Aggregate Decisions issued in 1st and 2nd Instance per month - See Appendix Table 11a

- The total of pending decisions of Appeals Authority (3.157 pending) consists of cases that have been discussed till May 2023 (2.672 pending) or are scheduled to be discussed till September 2023 (485 pending).




Chart 20. Aggregate pending decisions in 1st and 2nd instance regarding notification status per month - See Appendix Table 11c
















Chart 27. Recognition Rate in 1st & 2nd Instance. See Appendix Table 12g



# 11. Applications for annulment of 2<sup>nd</sup> Instance Decisions before the Administrative Court

The 30% of the total applications for annulment per year of lodging (5.418) are pending while for the rest of them (70%), a decision has been issued. 3,78% of the decisions had a positive outcome and 96,22% were rejected.

From the total of 3.810 decisions regarding applications for annulment (per year of decision) 48% have been issued in 2022 and 2023.

#### 12. HELIOS Integration Program

The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:

- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.

The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration. From 16/7/2019 until 31/5/2023 44.465 people have registered in the program, while 22.799 recognized refugees receive financial assistance for renting a house. It is worth noting that in May, 354 new leases were added to the accommodation support of the "Helios" program (regarding the period from 1/5/2023 till 31/5/2023). At the same time 9.748 beneficiaries of International Protection have been enrolled in the integration courses and 11.004 people are attending job counseling sessions.




Chart 30. Helios Enrollments - See Appendix Table 14




Chart 31. New leases (left), Receiving rental allowance (Right) - See Appendix Table 15 and 16

#### 13. Returns - Departures

In May 2023 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:

- 292 forced deportations and returns of third country nationals, based on agreements of the European Union, but also bilateral agreements of our country.
- 220 voluntary departures through IOM.
- 75 voluntary departures of immigrants from our country to their countries of origin.
- 16 transfers to Member States of the European Union under the Dublin Regulation.
- 65 people seeking International Protection were transferred to France (35) and Finland (30) in the context of voluntarily relocation program.
- Returns under the EU Turkey Joint Declaration have not been made since May 2020 due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures the requests of missions-returns of the Greek authorities have not been answered.
- A total of 668 people left the country in May, while 1.361 arrived.




Chart 32. Returns-Departures – See Appendix Table 17




Chart 33. Total Ukrainian Residents & Online pre-registrations of applications (May 2023) - See Appendix Table 18 & 19




Chart 34. Total card issues to Ukrainians for Temporary Protection per age group and gender (May 2023) - See Appendix Table 20
