Remarks: (i) The statistical data concerning unaccompanied minors are provided with every reservation as this is a dynamic phenomenon. It depends on the data or/and characterizations recorded by the respective graded operators in the FIRST RECEPTION Application and of course on the possible orders of the competent Prosecution Authorities regarding the assignment or non-assignment/care of minors. (ii) It should be noted that in the processing, analysis and recording of the data (of all diagrams) the movements to the mainland have not been taken into account. (iii) The defragmentation and generally the processing concerns a file extracted from the Database of the FIRST RECEPTION Application on **22/12/2022**.
