


Chart 1. Arrivals November 2022 – November 2023 – See Appendix Table 1




Chart 2. Transfers of asylum seekers from the islands to the mainland November 2022 - November 2023 - See Appendix Table 2




Chart 3. Island Residents in total November 2022 - November 2023 - See Appendix Table 3

4. Distribution of Asylum Seekers per Region and Accommodation scheme




Chart 4. Progress of Residents through time – See Appendix Table 6




Chart 5. Distribution of Asylum Seekers per Region and Accommodation scheme – See Appendix Table 4 & 5






Chart 8. Applications for International Protection per year. For 2023 applications are calculated till the month of reference (November) - See Appendix Table 8a

6b. Applications for International Protection per Regional Office or Asylum Unit and per Region



6c. Applications for International Protection per month with distinction between first time and subsequent




Chart 10. Applications for International Protection per month with distinction between first time and subsequent (November 2022 - November 2023) - See Appendix Table 8c




Chart 11. Applications for International Protection 11-months 2023 per Nationality (Top 10 Nationalities and distribution per continent) - See Appendix Table 8d




Chart 12. Applications for International Protection 11-months 2023 per gender and age group - See Appendix Table 8e







Chart 15. 2nd Instance Decisions per month and type for 2023 and for the month of reference (November 2023). - See Appendix Table 9b




Chart 16. Appeals that have been lodged the 11-months of 2023 per location and quarter – See Appendix Table 10a








Chart 19. Aggregate Decisions issued in 1st and 2nd Instance per month - See Appendix Table 11a
















Chart 27. Recognition Rate in 1st & 2nd Instance. See Appendix Table 12g



11. Applications for annulment of 2nd Instance Decisions before the Administrative Court

The 28% of the total applications for annulment per year of lodging (5.855) are pending while for the rest of them (72%), a decision has been issued. 4,3% of the decisions had a positive outcome and 95,7% were rejected.

From the total of 4.238 decisions regarding applications for annulment (per year of decision) 53% have been issued in 2022 and 2023.



12. HELIOS Integration Program

The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:

- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.

The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration. From 16/7/2019 until 30/9/2023 45.221 people have registered in the program, while 23.377 recognized refugees receive financial assistance for renting a house. It is worth noting that in November, 41 new leases were added to the accommodation support of the "Helios" program (regarding the period from 1/11/2023 till 30/11/2023). At the same time 10.081 beneficiaries of International Protection have been enrolled in the integration courses and 11.556 people are attending job counseling sessions.




Chart 30. Helios Enrollments – See Appendix Table 14




Chart 31. New leases (left), Receiving rental allowance (Right) - See Appendix Table 15 and 16

13. Returns - Departures

In November 2023 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:

- 244 forced deportations and returns of third country nationals, based on agreements of the European Union, but also bilateral agreements of our country.
- 271 voluntary departures through IOM.
- 56 voluntary departures of immigrants from our country to their countries of origin.
- 116 people seeking International Protection were transferred to France in the context of voluntarily relocation program.
- Returns under the EU Turkey Joint Declaration have not been made since March 2020 due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures the requests of missions-returns of the Greek authorities have not been answered.
- A total of 687 people left the country in November, while 4.584 arrived.






Chart 33. Total Ukrainian Residents & Online pre-registrations of applications (November 2023) - See Appendix Table 18 & 19




Chart 34. Total card issues to Ukrainians for Temporary Protection per age group and gender (November 2023) - See Appendix Table 20
