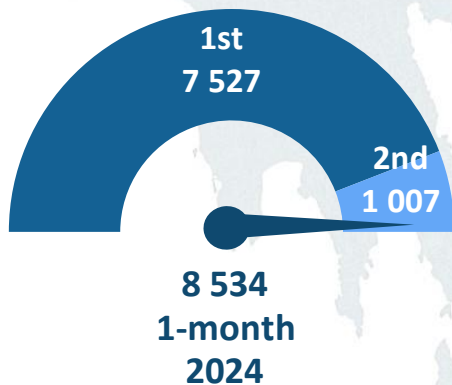

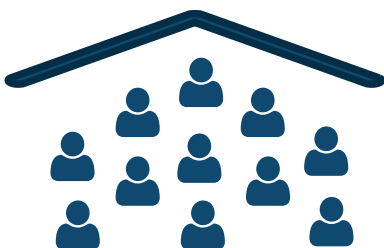

Arrivals increased by 97% in January 2024 compared to the corresponding month of 2023.

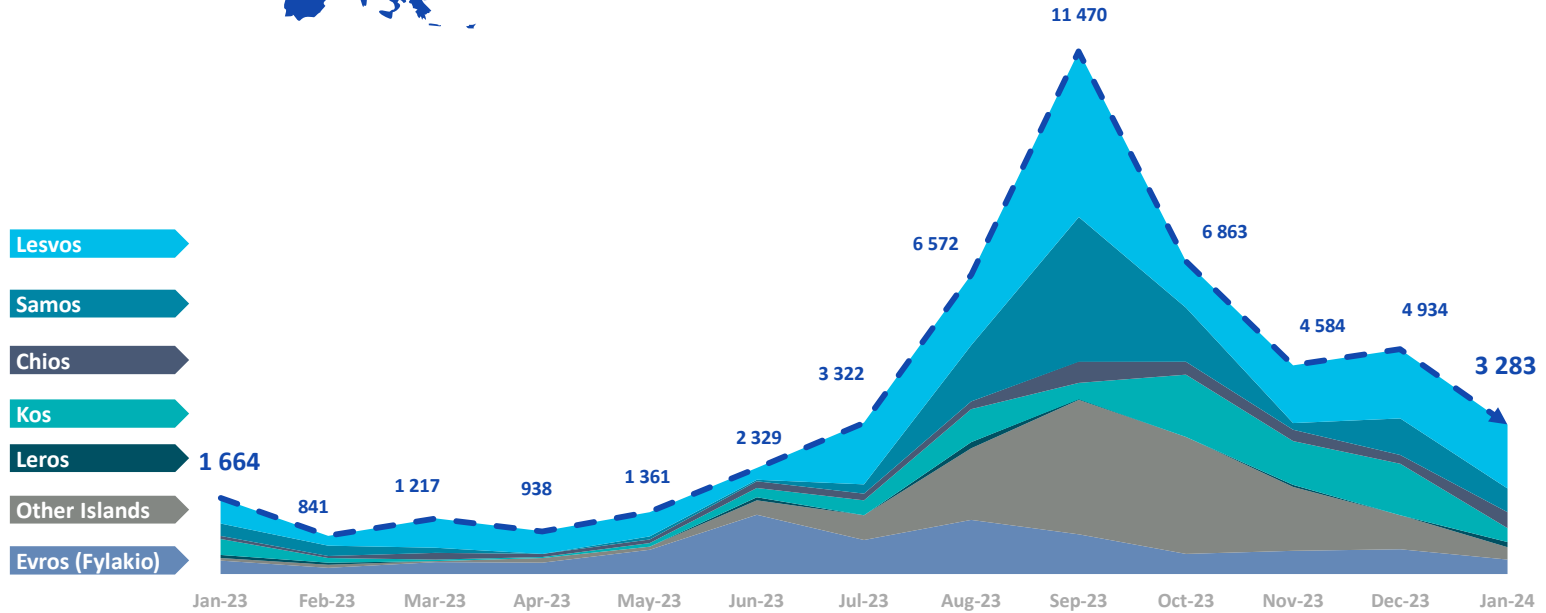


Chart 1. Arrivals January 2023 – January 2024 – See Appendix Table 1

Transfers in January 2024 increased by 145% compared to the corresponding month of 2023.

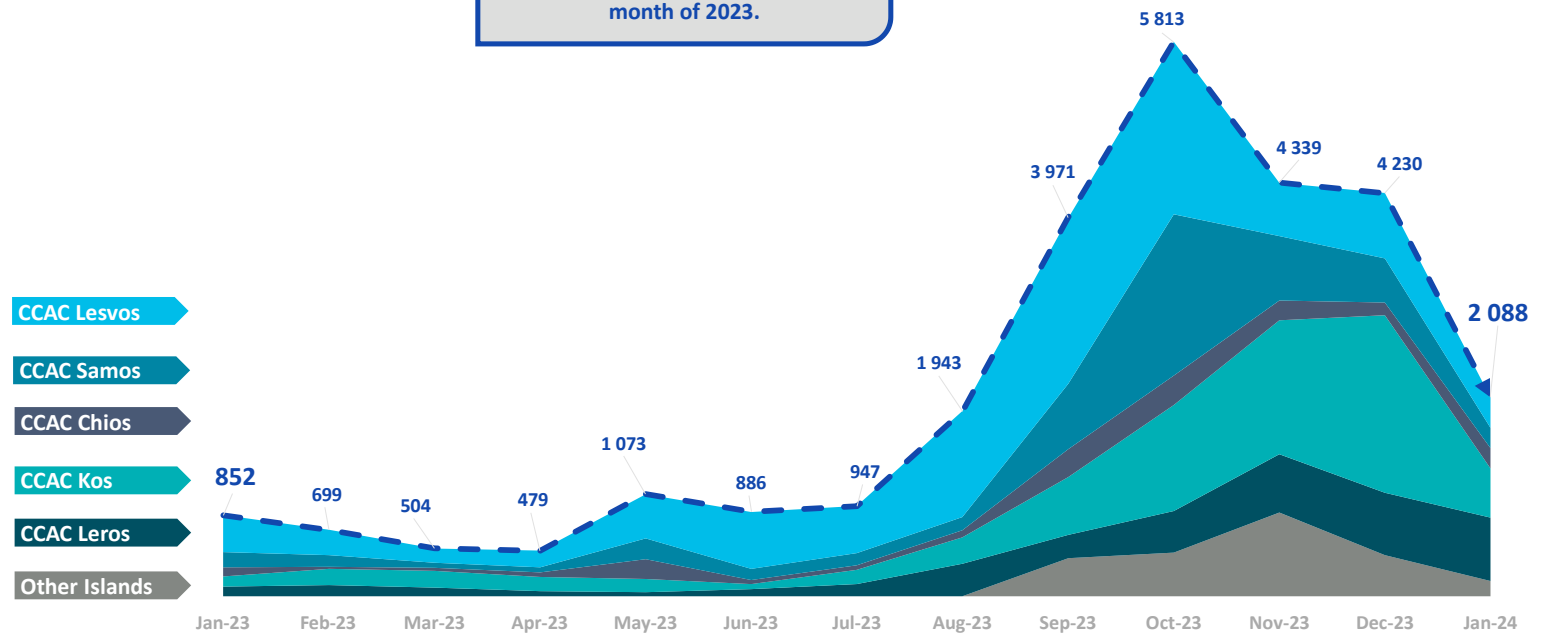


Chart 2. Transfers of asylum seekers from the islands to the mainland January 2023 – January 2024 - See Appendix Table 2

The residents in the islands increased by 232% in January 2024 compared to the corresponding month of 2023.

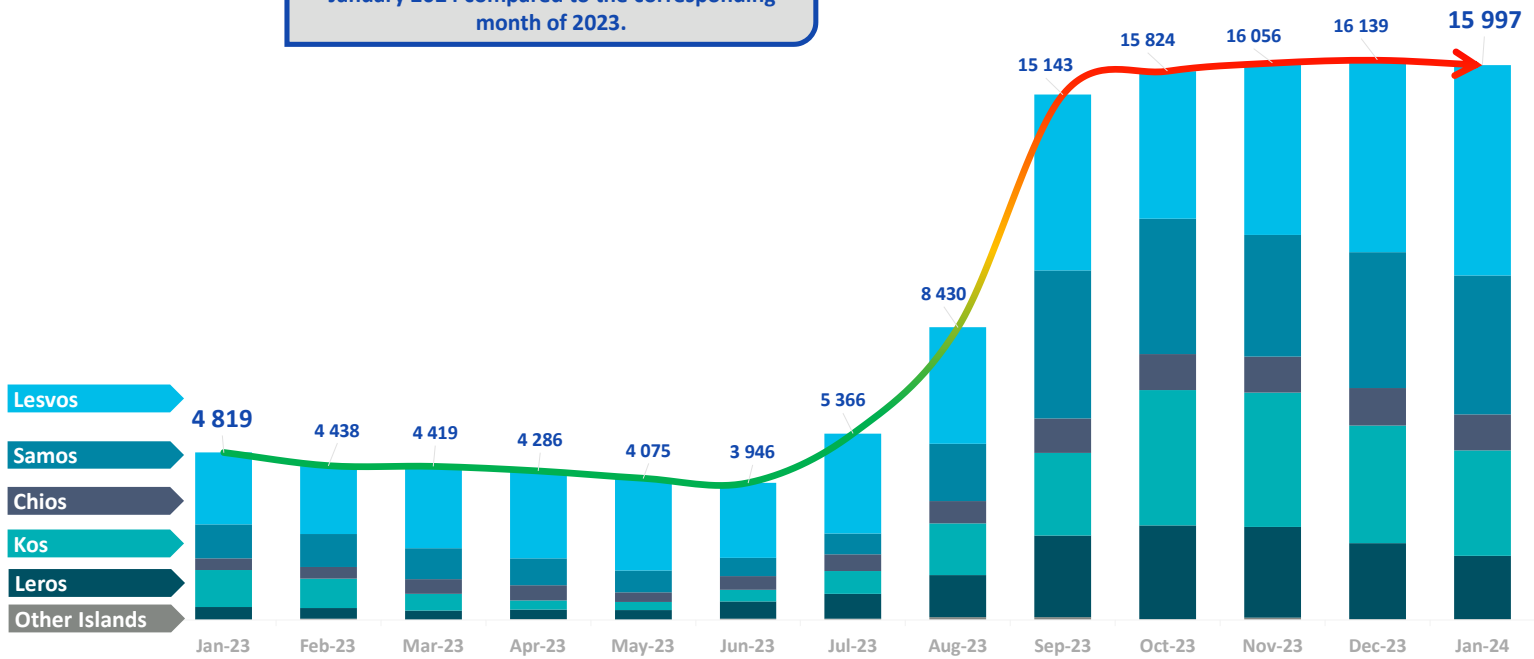


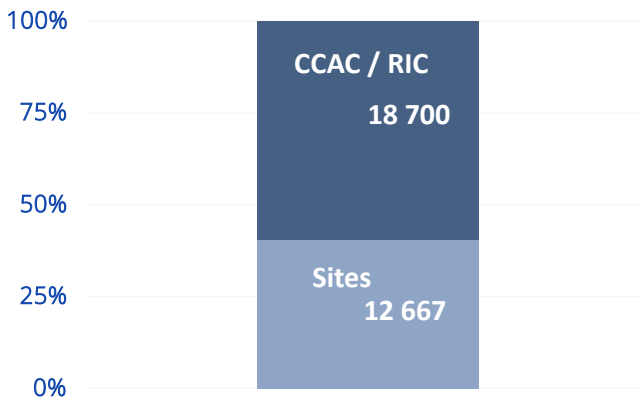
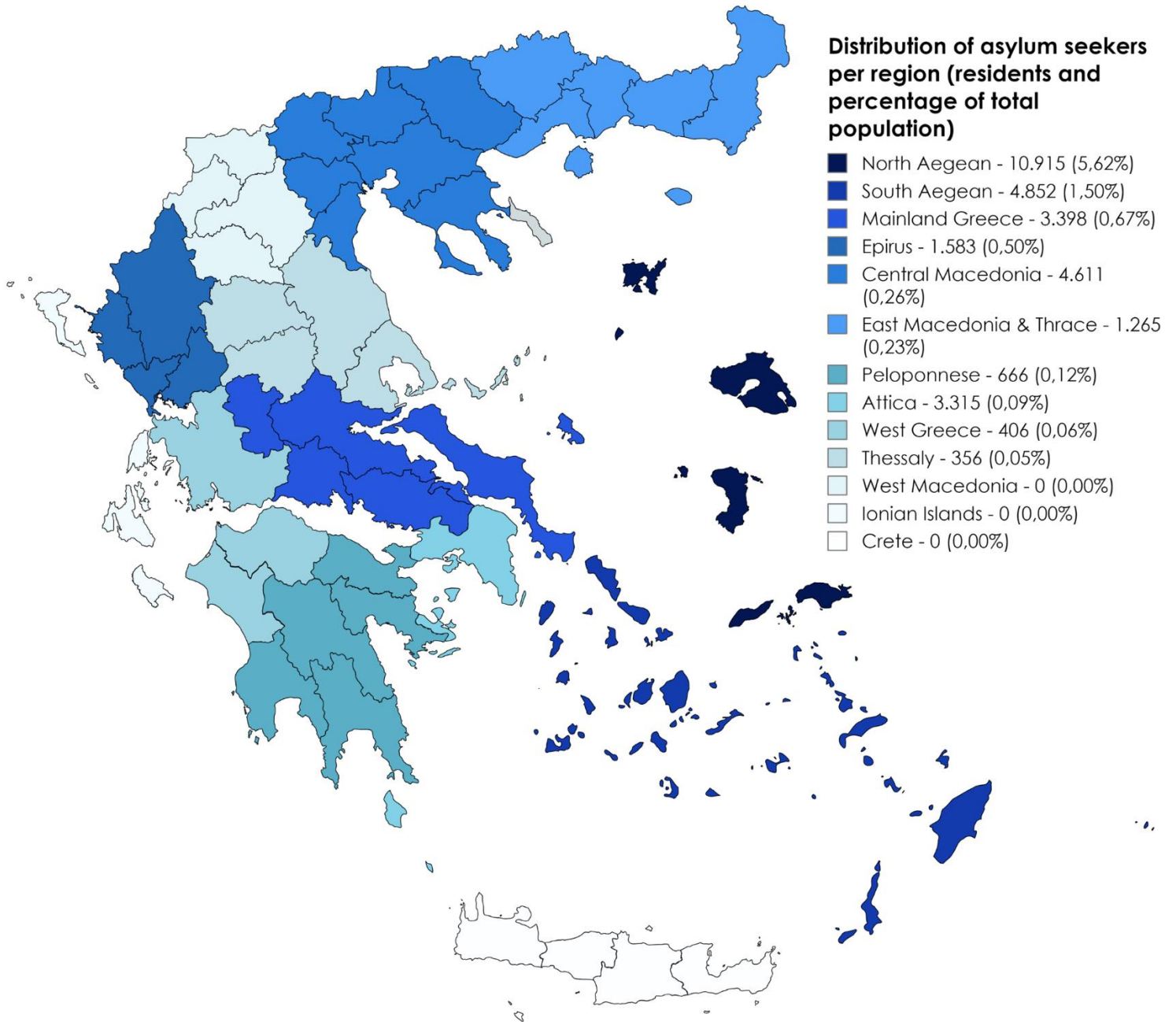
Chart 3. Island Residents in total January 2023 - January 2024 - See Appendix Table 3

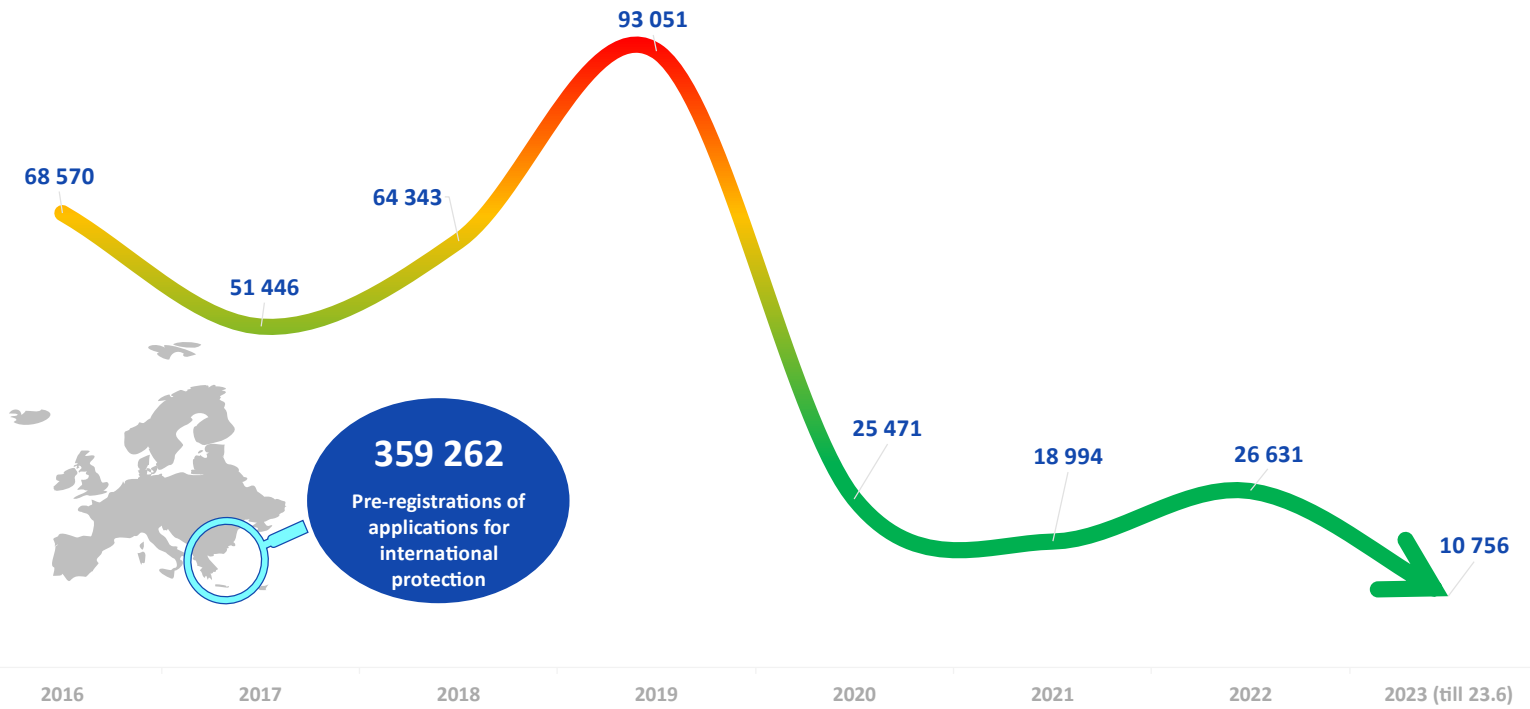

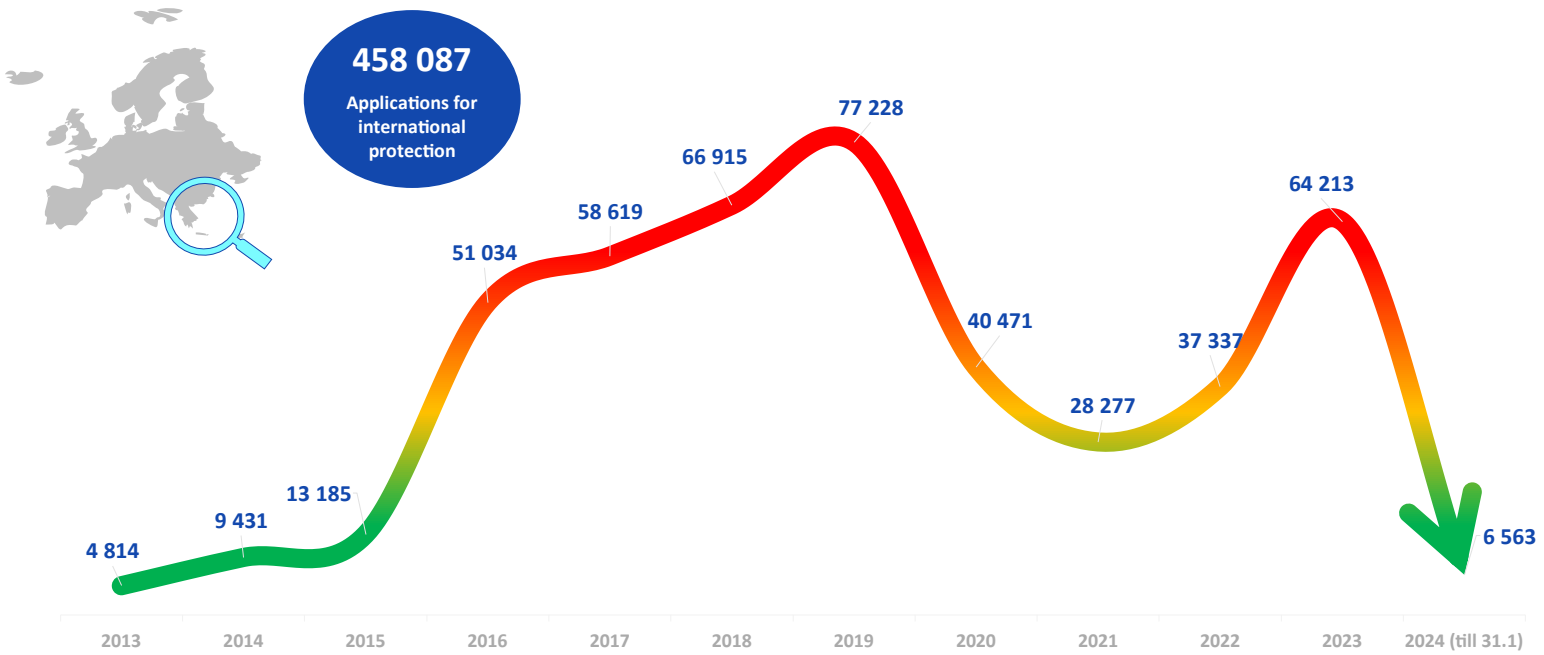


Chart 8. Applications for International Protection per year. For 2024 applications are calculated till the month of reference (January) - See Appendix Table 8a

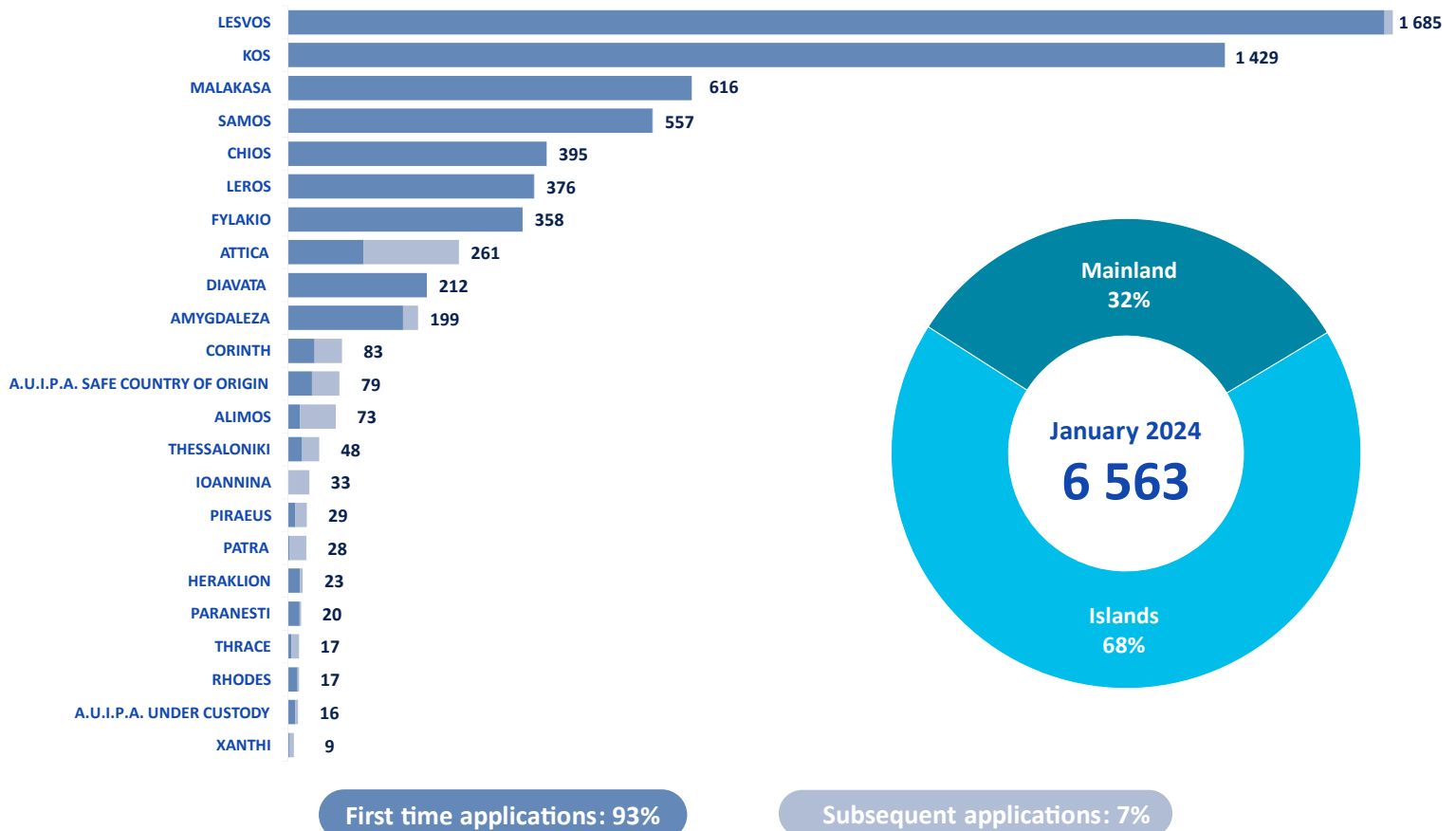

6c. Applications for International Protection per month with distinction between first time and subsequent

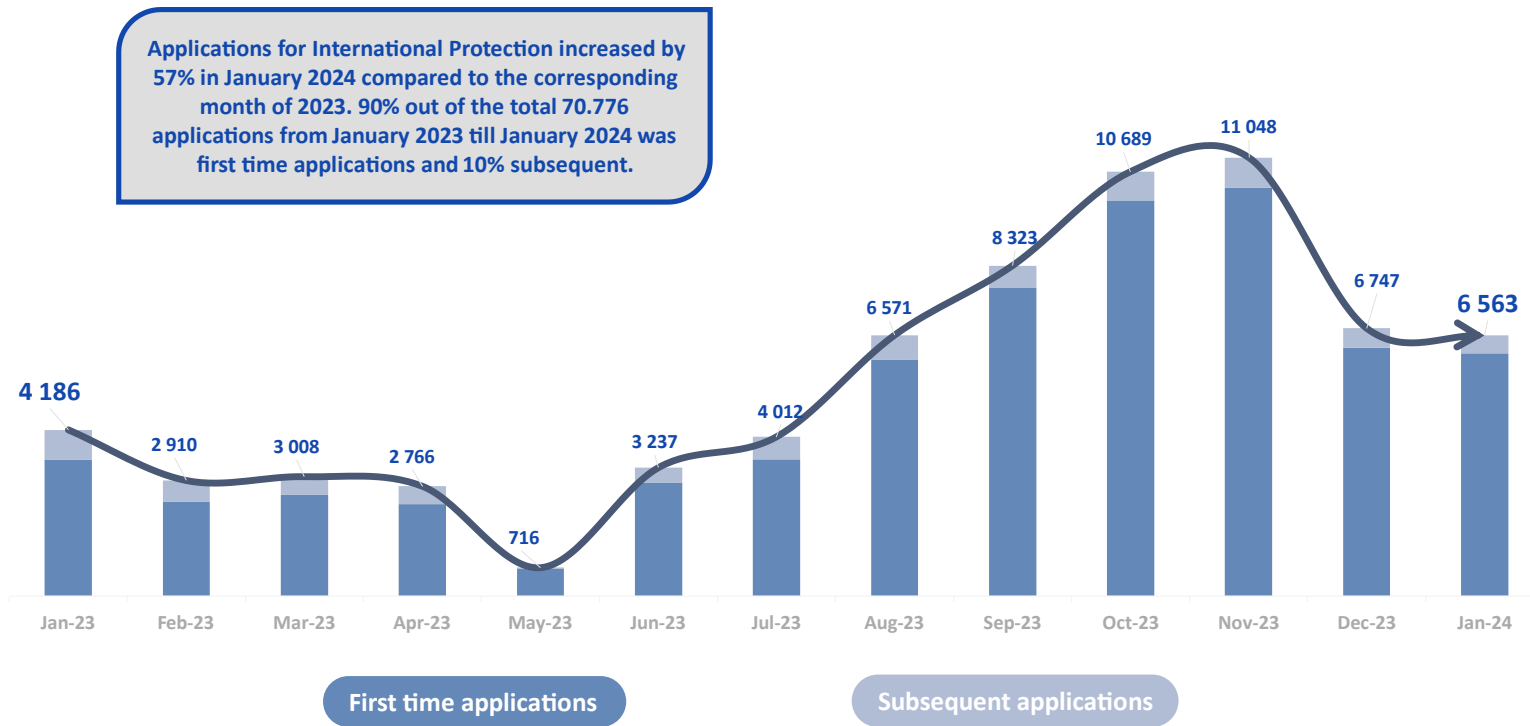


Chart 10. Applications for International Protection per month with distinction between first time and subsequent (January 2023 - January 2024) - See Appendix Table 8c

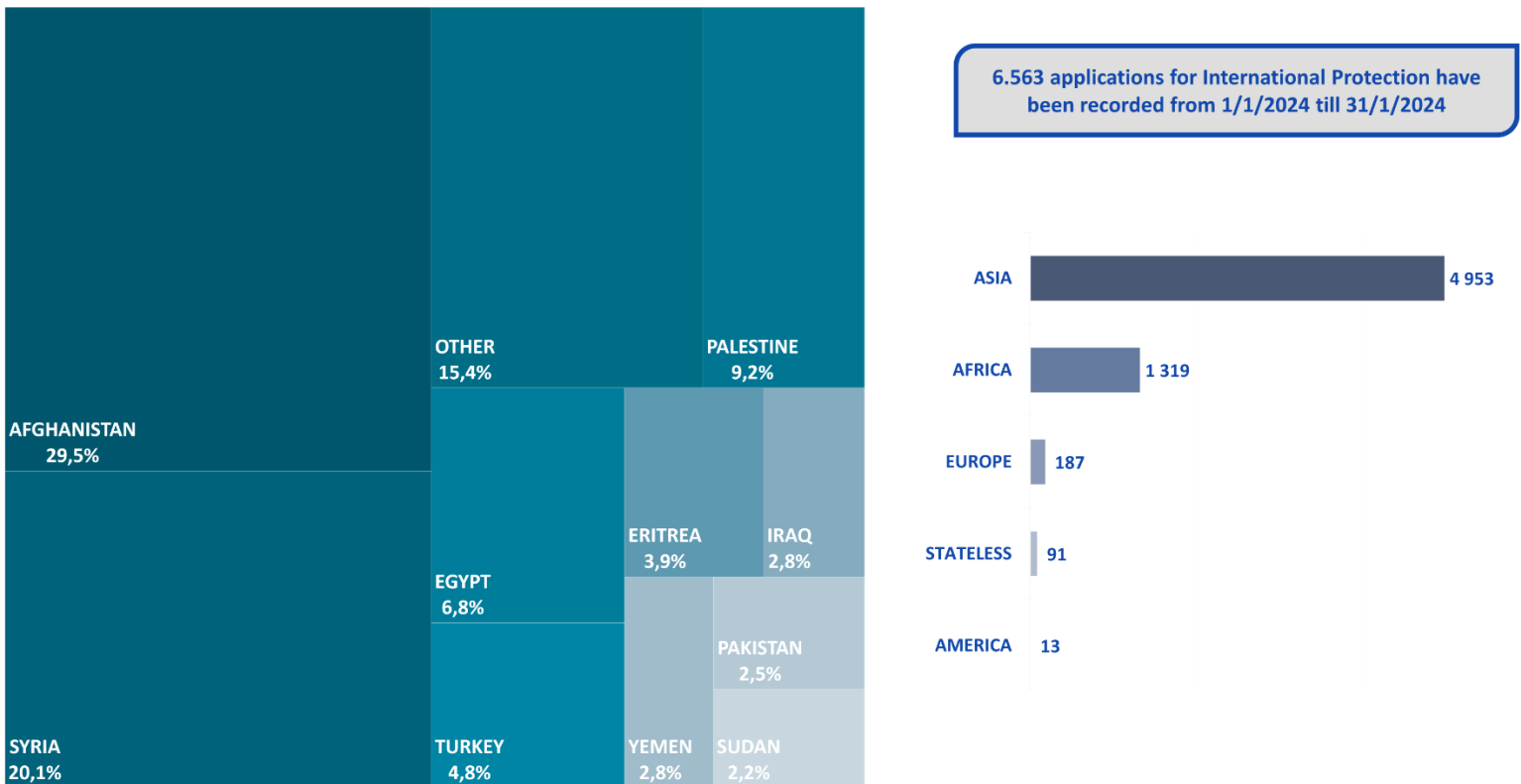


Chart 11. Applications for International Protection 1-month 2024 per Nationality (Top 10 Nationalities and distribution per continent) - See Appendix Table 8d

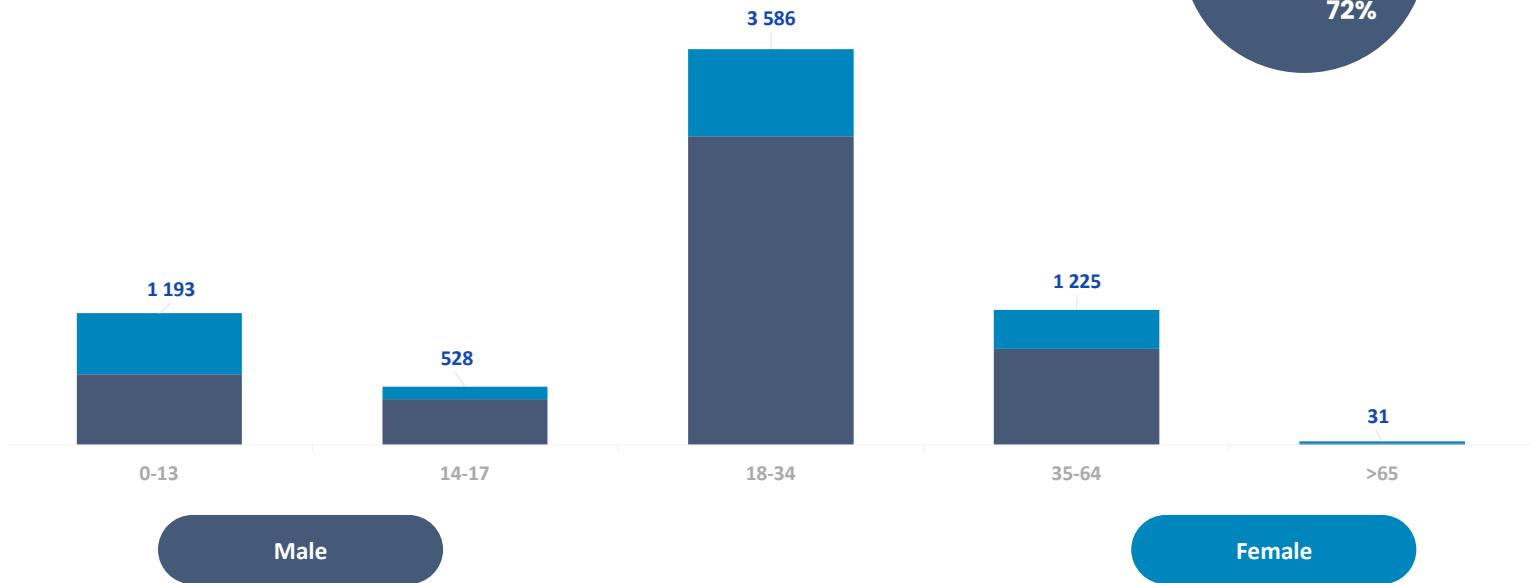
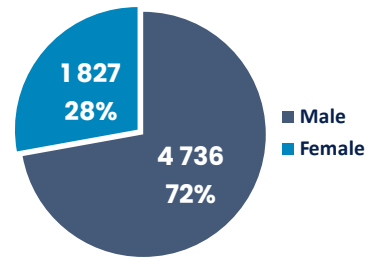


Chart 12. Applications for International Protection 1-month 2024 per gender and age group - See Appendix Table 8e

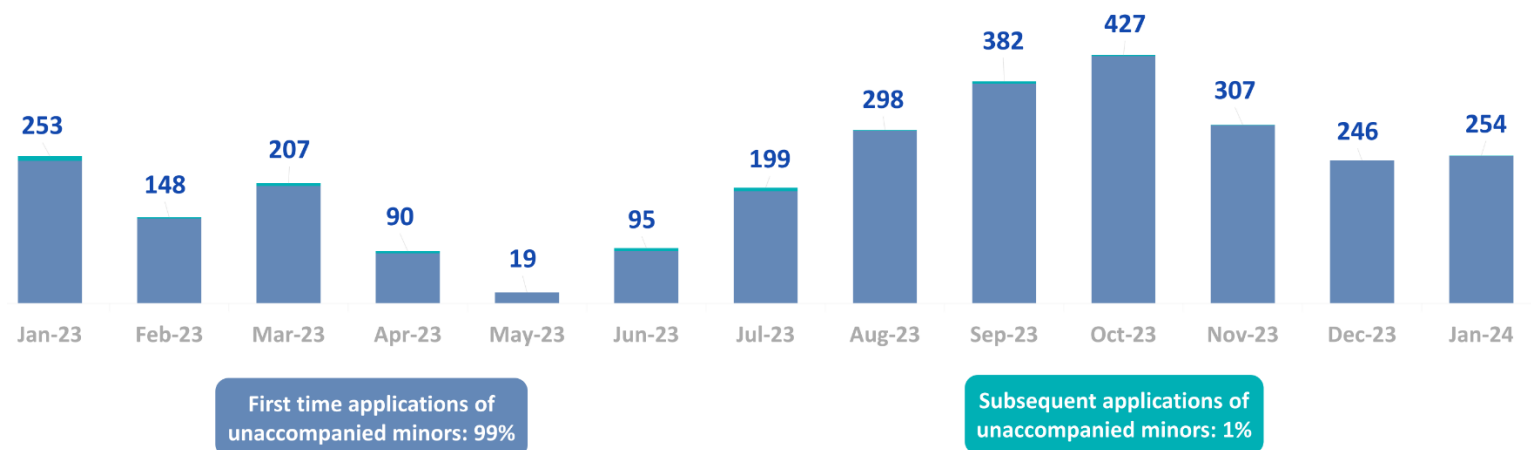
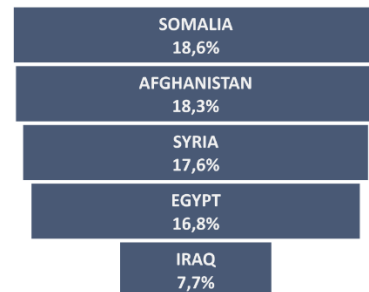
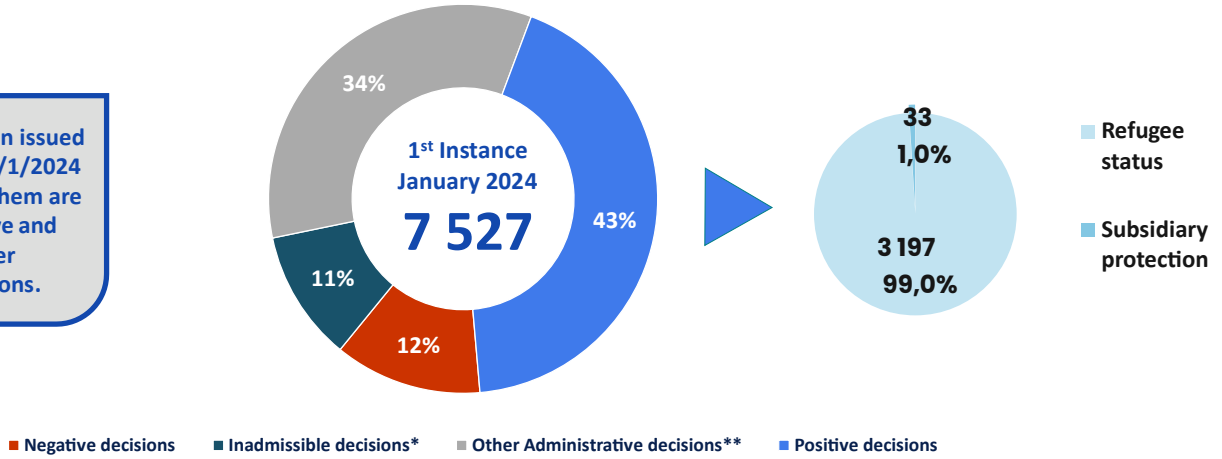

7a. Type of Decisions – 1st Instance

7.527 decisions have been issued in the 1st Instance from 1/1/2024 till 31/1/2024. 42,9% of them are positive, 23,2% negative and 33,9% refer to other administrative decisions.

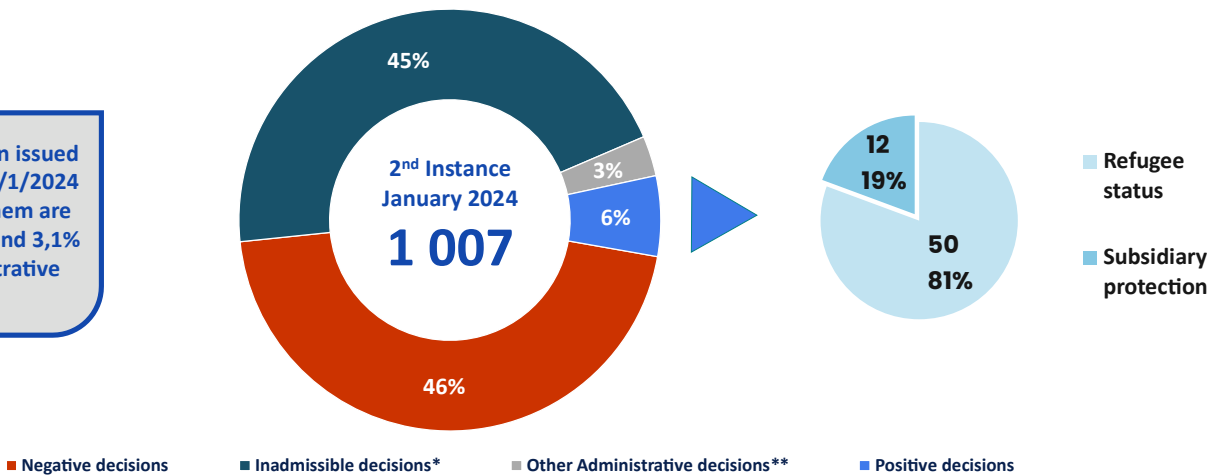


Chart 15. 2nd Instance Decisions per month and type for 2024 and for the month of reference (January 2024). - See Appendix Table 9b

Appeals in the 1-month of 2024 decreased by 15% compared to the 1-month of 2023.

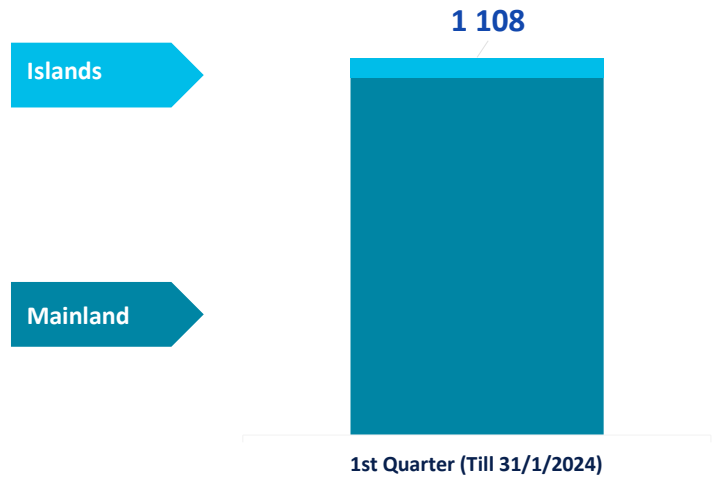


Chart 16. Appeals that have been lodged the 1-month of 2024 per location and quarter – See Appendix Table 10a

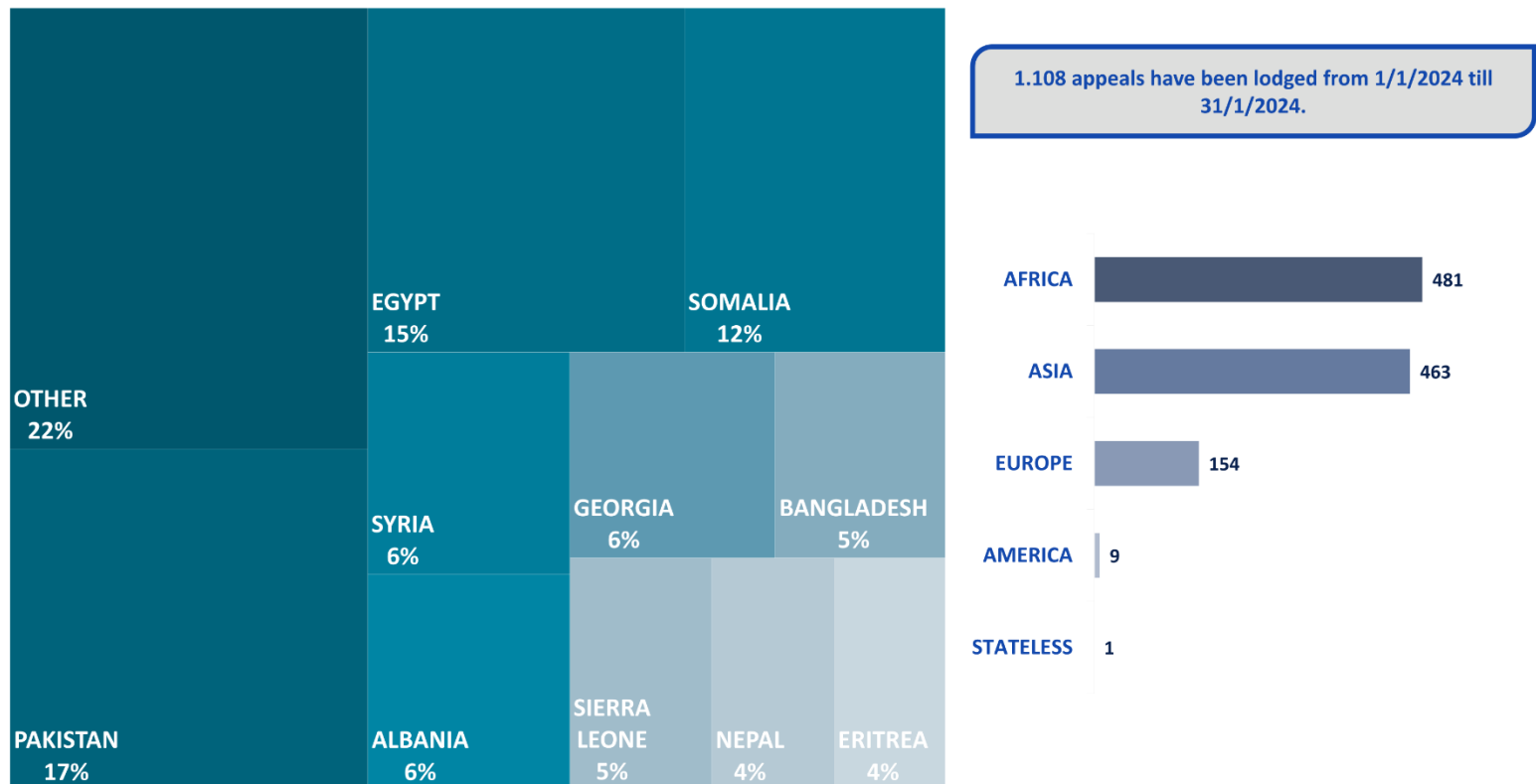

9a. Pending Pre-Registrations of applications for International Protection – Decisions issued in 1st and 2nd Instance

The total backlog (pending applications and decisions) increased by 42% in January 2024 compared to the corresponding month of 2023.

- The total of pending decisions of Appeals Authority (2,960 pending) consists of cases that have been discussed till January 2024 (1,955 pending) or are scheduled to be discussed till April 2024 (1,005 pending).

A comparison between January 2024 and January 2023 shows that the pending decisions in 1st and 2nd instance regarding notification status have been decreased by 40%

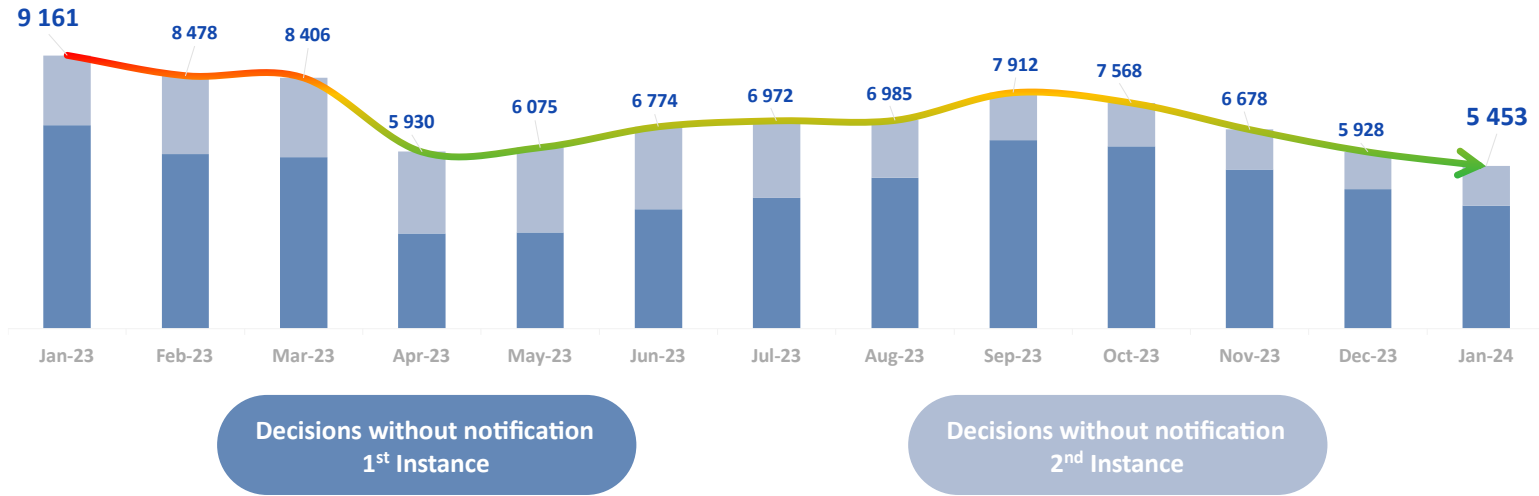


Chart 20. Aggregate pending decisions in 1st and 2nd instance regarding notification status per month - See Appendix Table 11c

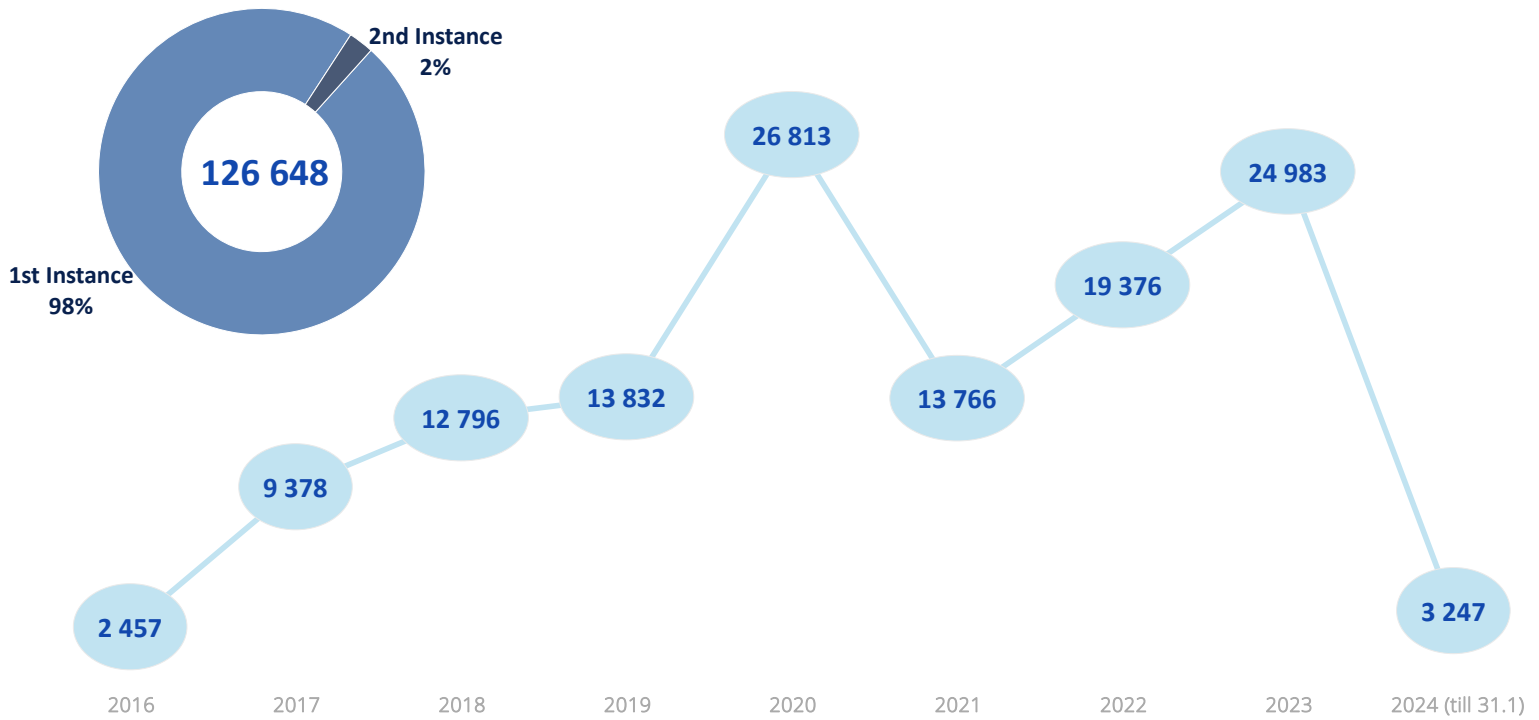

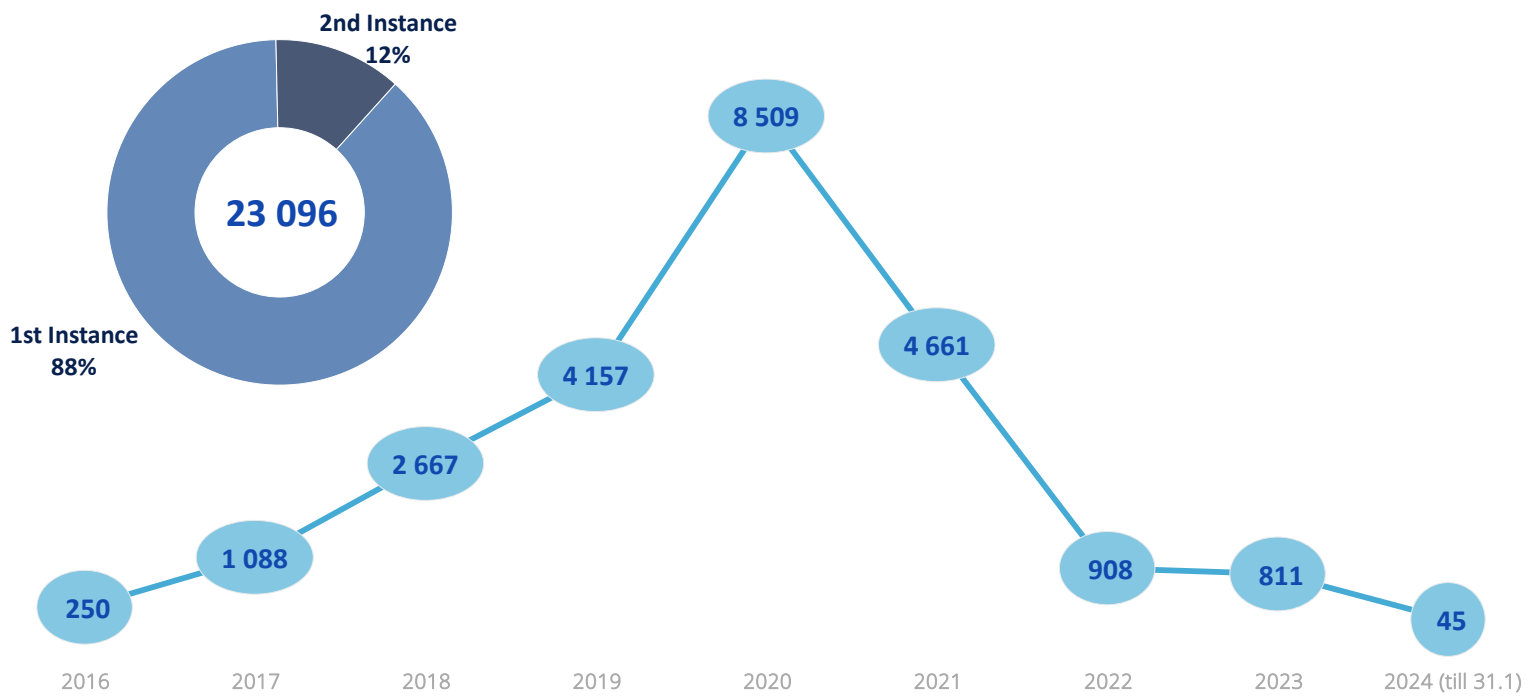
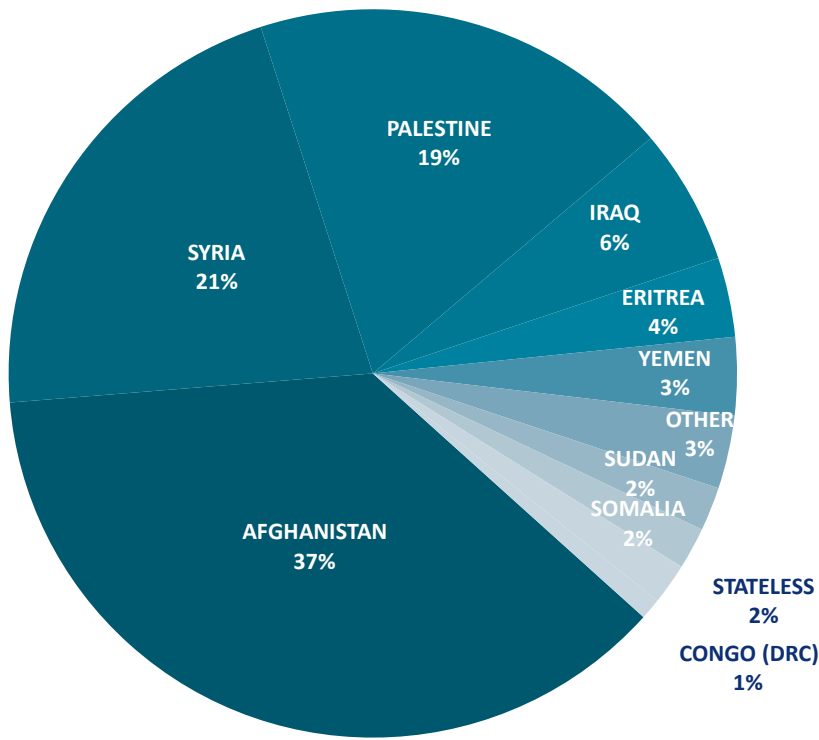

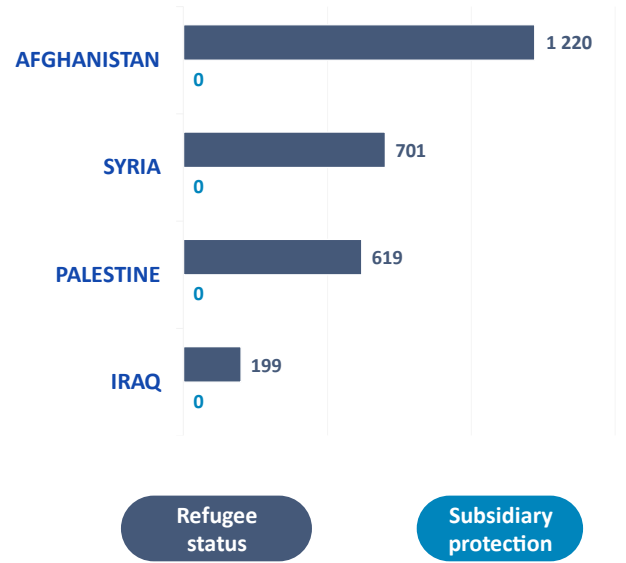

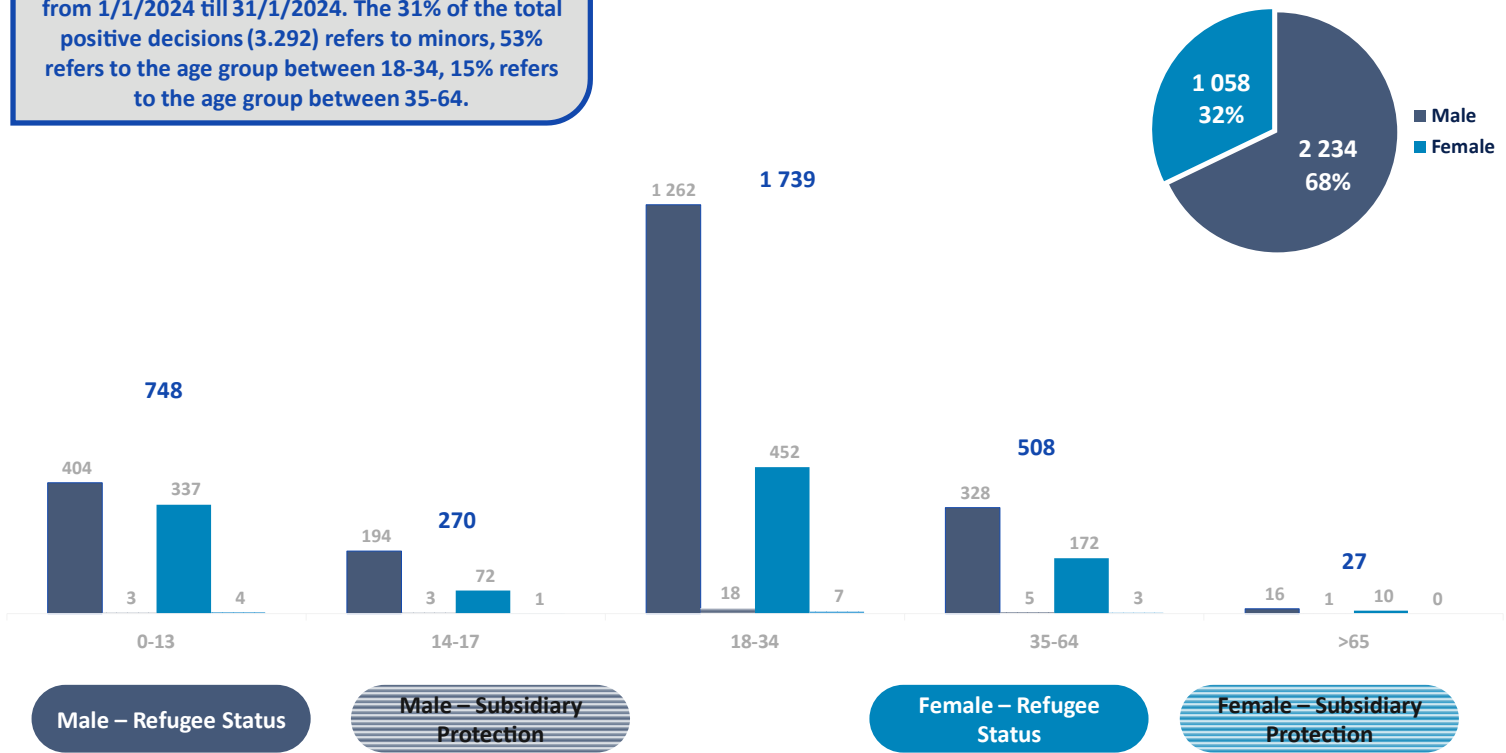
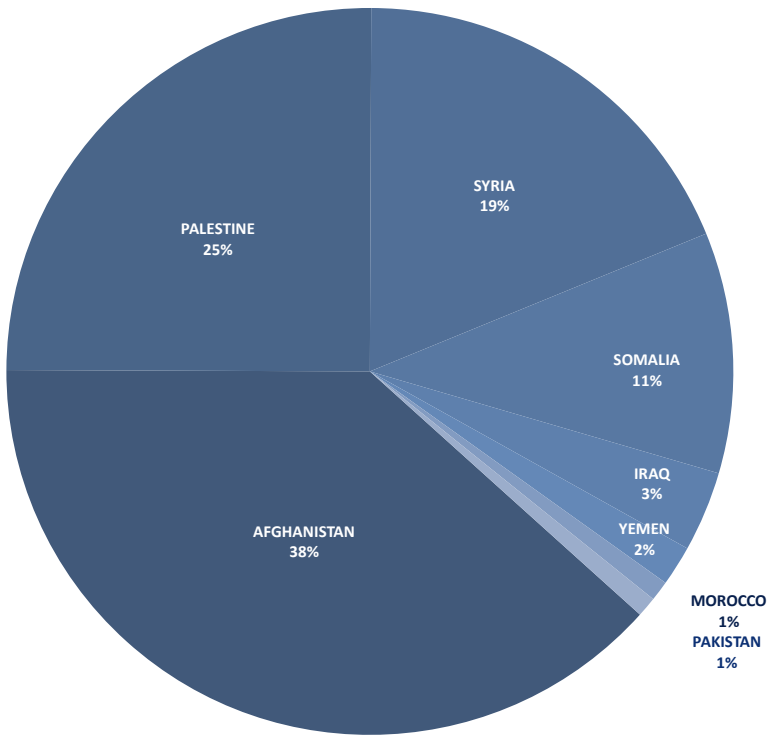

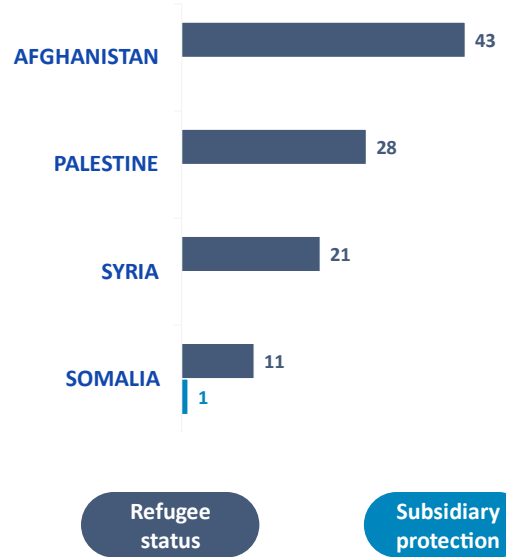

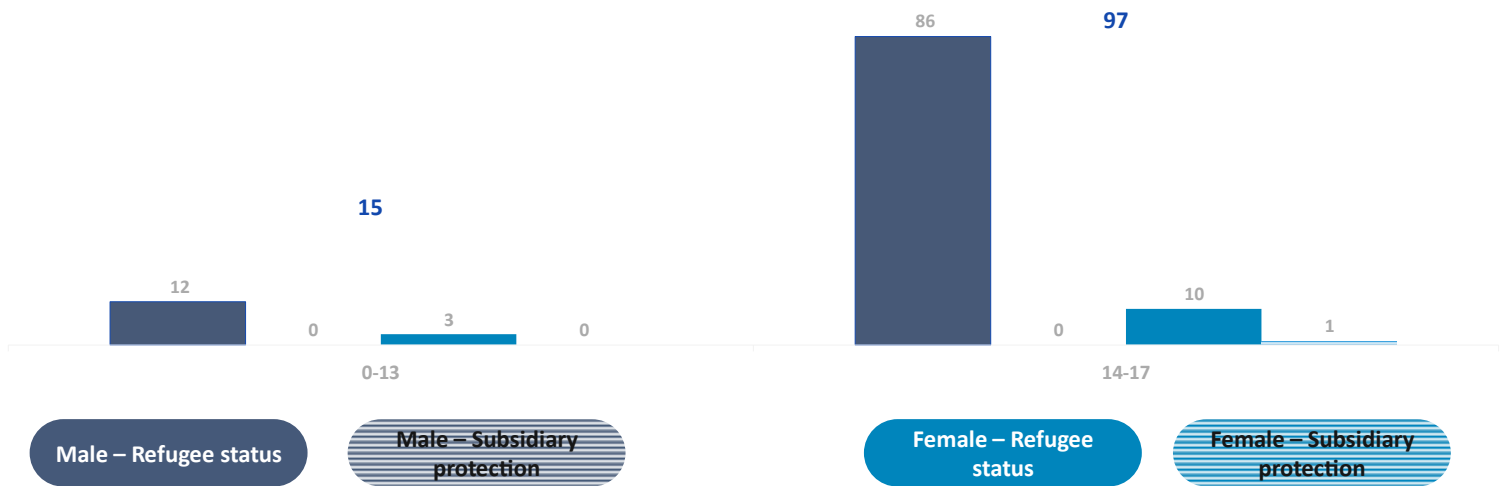
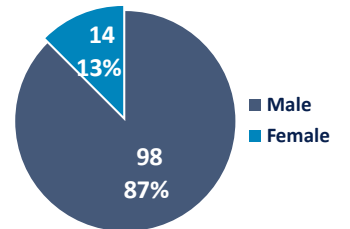

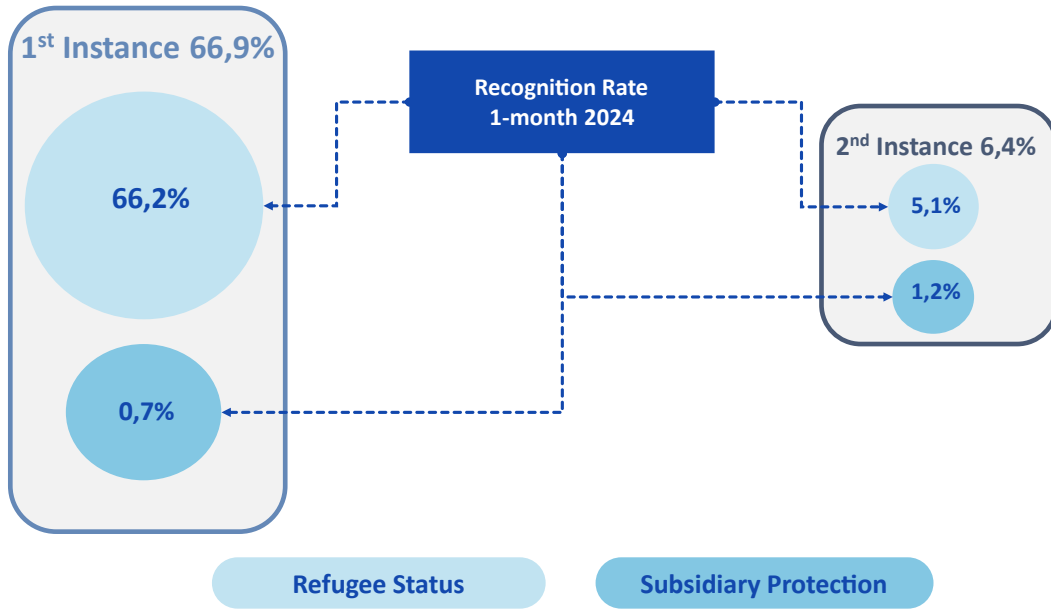


Chart 27. Recognition Rate in 1st & 2nd Instance. See Appendix Table 12g

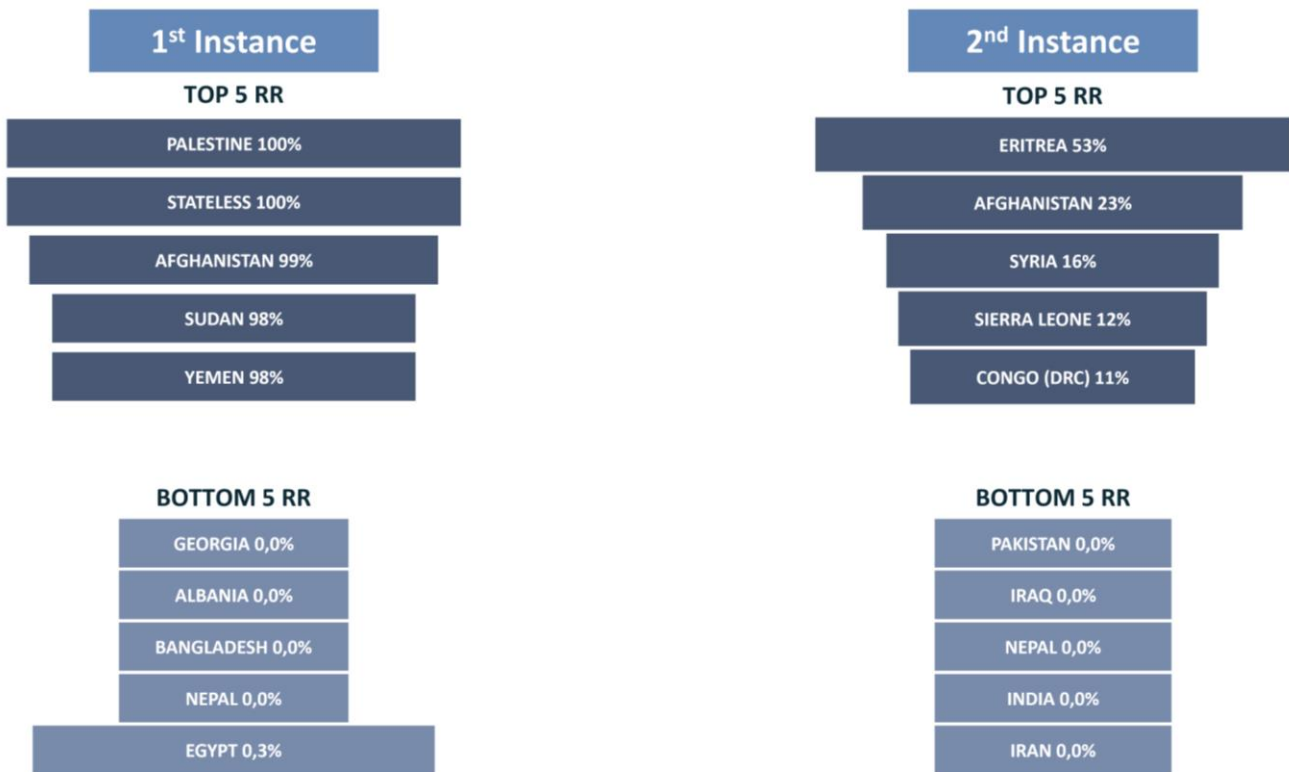

11. Applications for annulment of 2nd Instance Decisions before the Administrative Court

The 27% of the total applications for annulment per year of lodging (5,951) are pending while for the rest of them (73%), a decision has been issued. 4,4% of the decisions had a positive outcome and 95,6% were rejected.

From the total of 4,321 decisions regarding applications for annulment (per year of decision) 54% have been issued in 2022, 2023 and 2024.

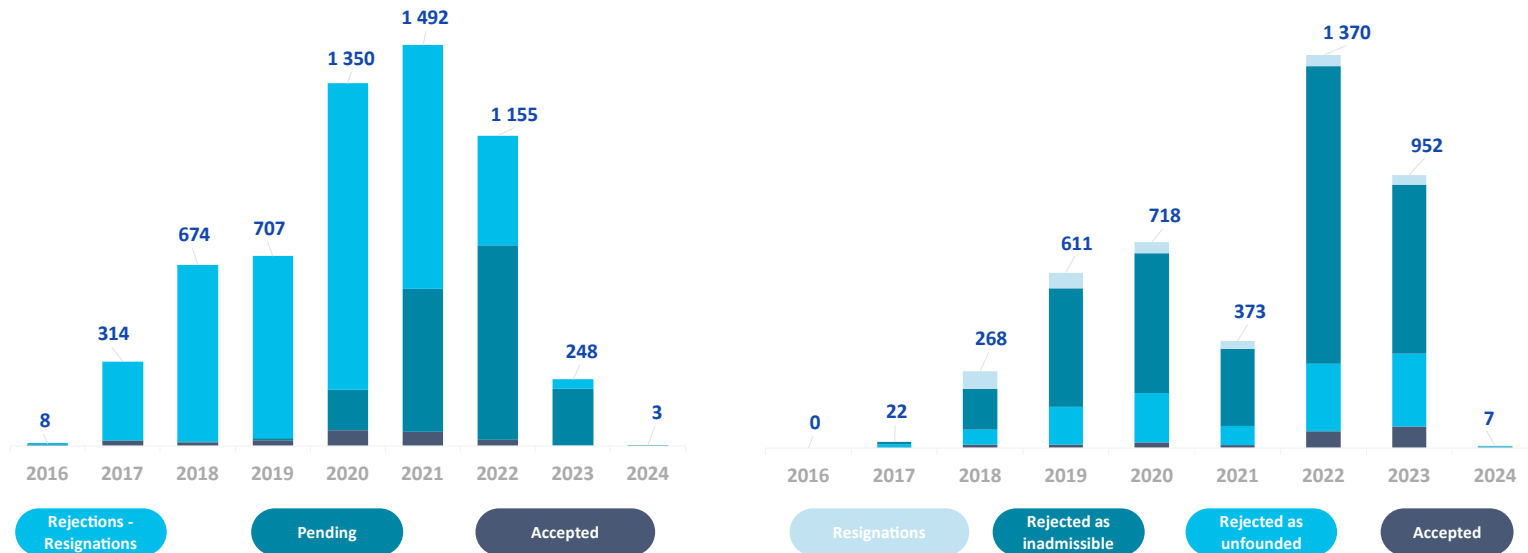

12. HELIOS Integration Program

The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:

- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.

The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration. From 16/7/2019 until 31/1/2024 45.254 people have registered in the program, while 23.384 recognized refugees receive financial assistance for renting a house. It is worth noting that in December 2023, 7 new leases were added to the accommodation support of the "Helios" program (regarding the period from 1/12/2023 till 31/12/2023). At the same time 10.080 beneficiaries of International Protection have been enrolled in the integration courses and 11.603 people are attending job counseling sessions.

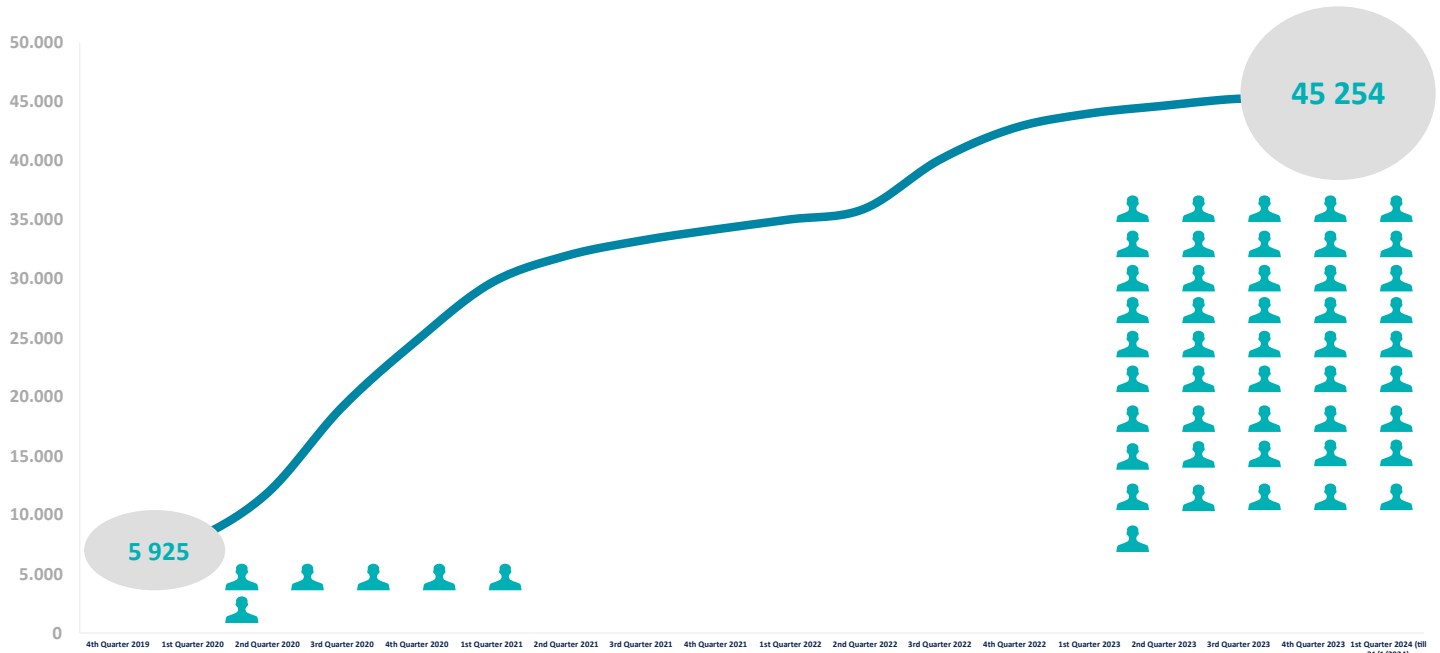


Chart 30. Helios Enrollments – See Appendix Table 14

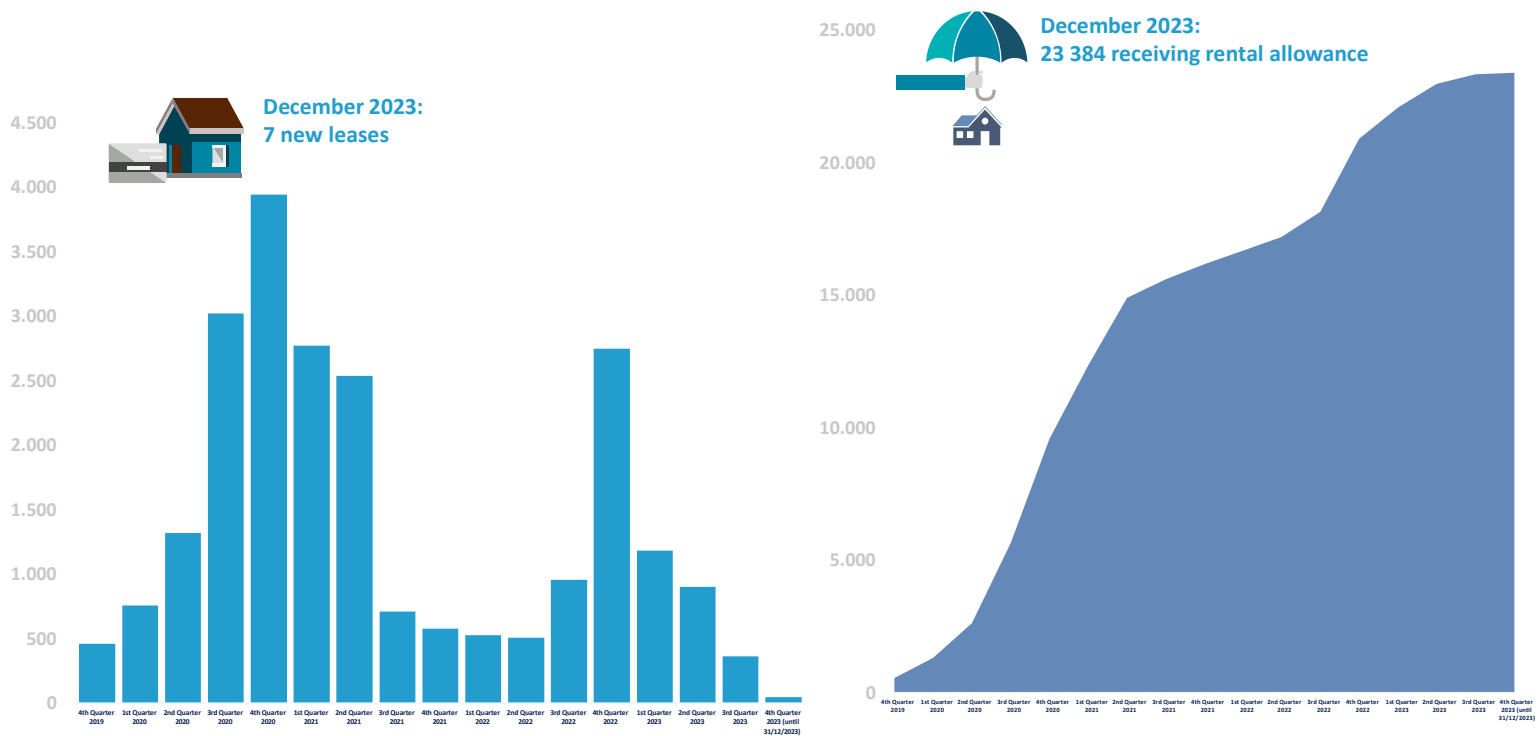


Chart 31. New leases (left), Receiving rental allowance (Right) - See Appendix Table 15 and 16

13. Returns - Departures

In January 2024 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:

- 199 forced deportations and returns of third country nationals, based on agreements of the European Union, but also bilateral agreements of our country.
- 198 voluntary departures through IOM.
- 44 voluntary departures of immigrants from our country to their countries of origin.
- Returns under the EU - Turkey Joint Declaration have not been made since March 2020 due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures the requests of missions-returns of the Greek authorities have not been answered.
- A total of 441 people left the country in January, while 3.283 arrived.

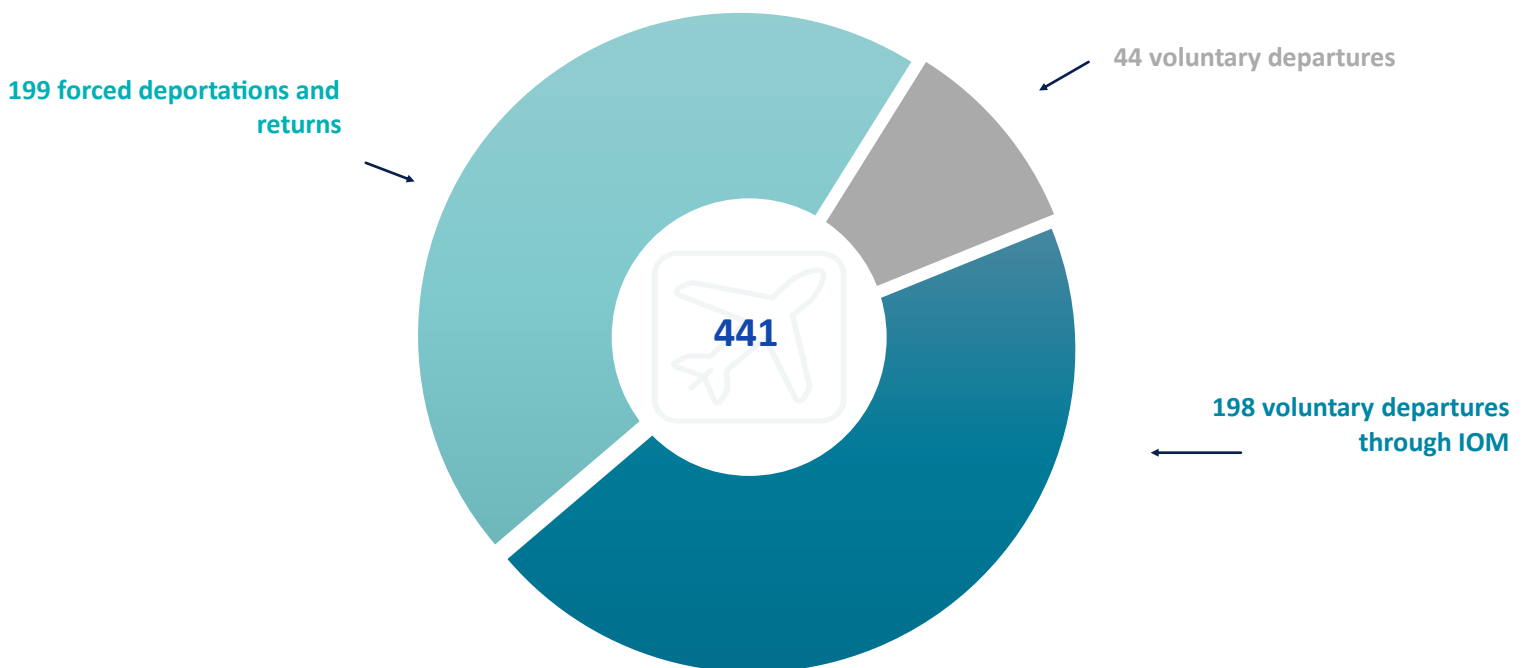

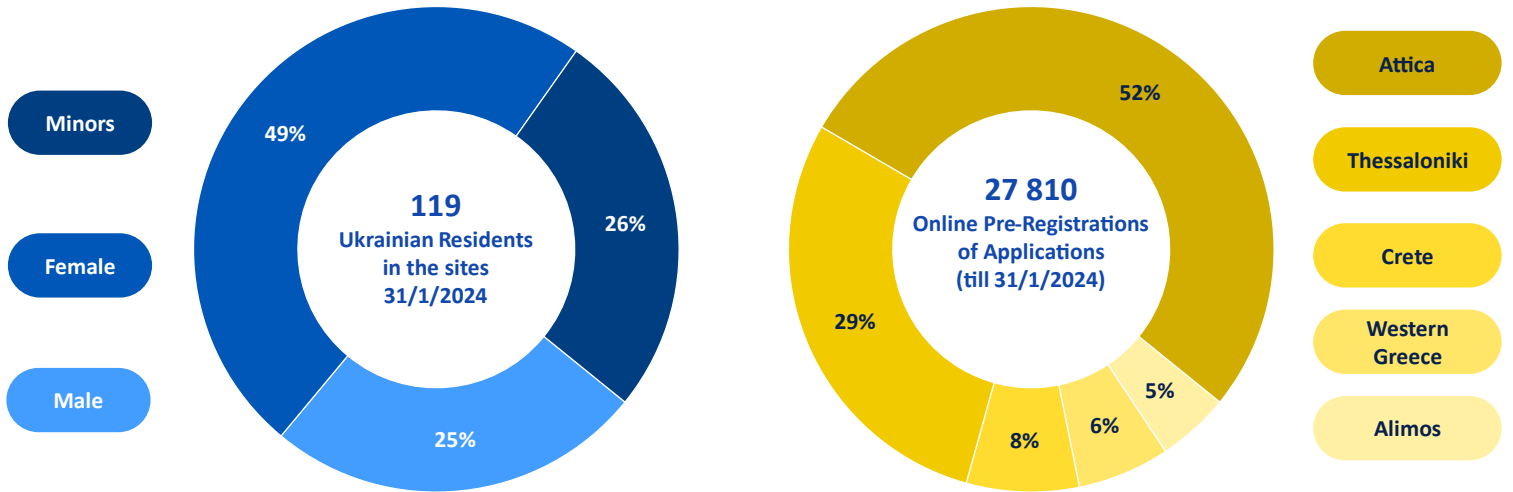


Chart 33. Total Ukrainian Residents & Online pre-registrations of applications (January 2024) - See Appendix Table 18 & 19

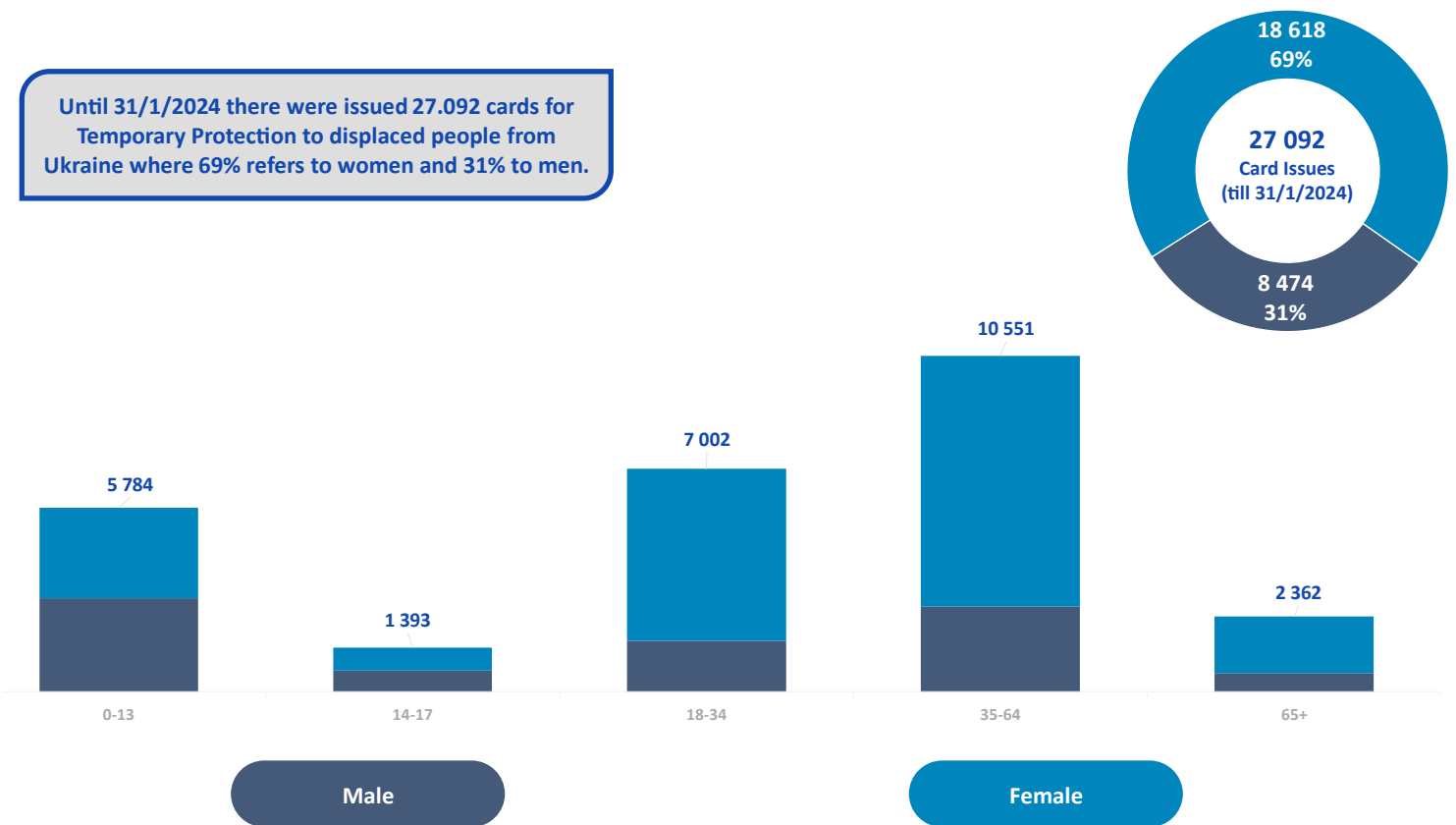


Chart 34. Total card issues to Ukrainians for Temporary Protection per age group and gender (January 2024) - See Appendix Table 20
