


Chart 1. Arrivals February 2023 – February 2024 – See Appendix Table 1




Chart 2. Transfers of asylum seekers from the islands to the mainland February 2023 – February 2024 - See Appendix Table 2




Chart 3. Island Residents in total February 2023 - February 2024 - See Appendix Table 3




Chart 4. Progress of Residents through time - See Appendix Table 6




Chart 5. Distribution of Asylum Seekers per Region and Accommodation scheme – See Appendix Table 4 & 5






Chart 8. Applications for International Protection per year. For 2024 applications are calculated till the month of reference (February) - See Appendix Table 8a






Chart 10. Applications for International Protection per month with distinction between first time and subsequent (February 2023 - February 2024) - See Appendix Table 8c




Chart 11. Applications for International Protection 2-months 2024 per Nationality (Top 10 Nationalities and distribution per continent) - See Appendix Table 8d




Chart 12. Applications for International Protection 2-months 2024 per gender and age group - See Appendix Table 8e







Chart 15. 2<sup>nd</sup> Instance Decisions per month and type for 2024 and for the month of reference (February 2024). - See Appendix Table 9b




Chart 16. Appeals that have been lodged the 2-months of 2024 per location and quarter – See Appendix Table 10a







- The average time for a 2nd Instance decision to be issued is 91 days since the date of appeal lodging, while it is 52 days from the date of appeal discussion.
- The total of pending decisions of Appeals Authority (2.633 pending) consists of cases that have been discussed till February 2024 (1.578 pending) or are scheduled to be discussed till June 2024 (1.055 pending).
















Chart 27. Recognition Rate in 1st & 2nd Instance. See Appendix Table 12g

# 11. Applications for annulment of 2<sup>nd</sup> Instance Decisions before the Administrative Court

The 27,6% of the total applications for annulment per year of lodging (5.992) are pending while for the rest of them (72,4%), a decision has been issued. 4,4% of the decisions had a positive outcome and 95,6% were rejected.

From the total of 4.341 decisions regarding applications for annulment (per year of decision) 54% have been issued in 2022, 2023 and 2024.

#### 12. HELIOS Integration Program

The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:

- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.

The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration. From 16/7/2019 until 29/2/2024 45.688 people have registered in the program, while 23.459 recognized refugees receive financial assistance for renting a house. It is worth noting that in February 2024, 74 new leases were added to the accommodation support of the "Helios" program (regarding the period from 1/2/2024 till 29/2/2024). At the same time 10.151 beneficiaries of International Protection have been enrolled in the integration courses and 11.698 people are attending job counseling sessions.




Chart 30. Helios Enrollments - See Appendix Table 14




Chart 31. New leases (left), Receiving rental allowance (Right) - See Appendix Table 15 and 16

#### 13. Returns - Departures

In February 2024 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:

- 227 forced deportations and returns of third country nationals, based on agreements of the European Union, but also bilateral agreements of our country.
- 155 voluntary departures through IOM.
- 70 voluntary departures of immigrants from our country to their countries of origin.
- 109 people seeking International Protection were transferred to France (101) and Romania (8) in the context of voluntarily relocation program.
- Returns under the EU Turkey Joint Declaration have not been made since March 2020 due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures the requests of missions-returns of the Greek authorities have not been answered.
- A total of 561 people left the country in February, while 3.828 arrived.






Chart 33. Total Ukrainian Residents & Online pre-registrations of applications (February 2024) - See Appendix Table 18 & 19




Chart 34. Total card issues to Ukrainians for Temporary Protection per age group and gender (February 2024) - See Appendix Table 20
