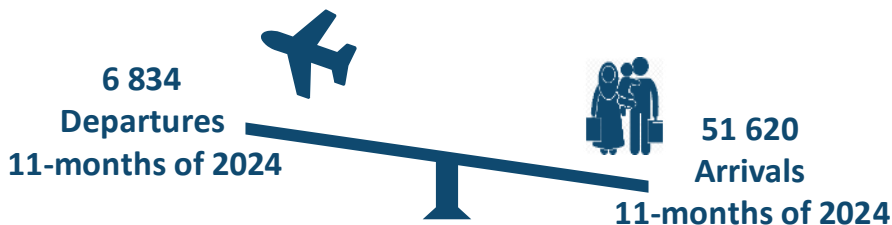
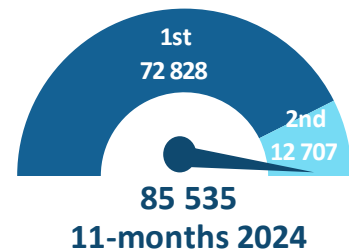

Arrivals increased by 55% in November 2024 compared to the corresponding month of 2023.

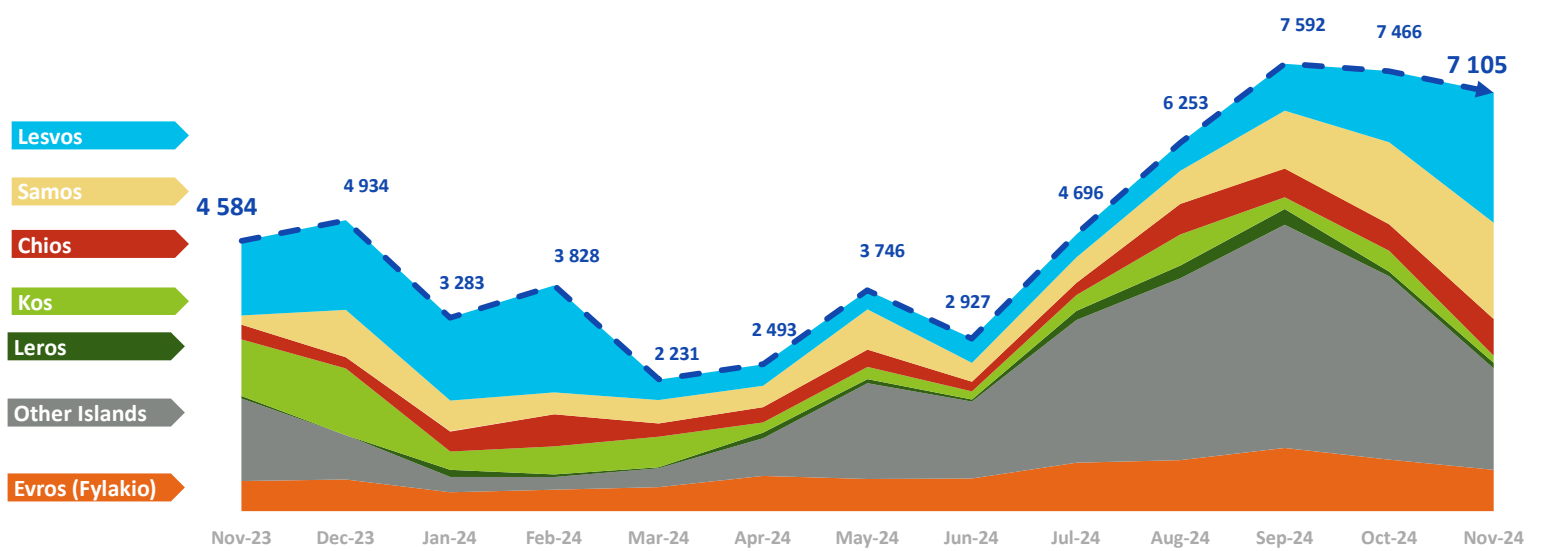


Chart 1. Migration flows (islands of Eastern Aegean sea and Evros) November 2023 – November 2024 – See Appendix Table 1

Transfers in November 2024 increased by 0,02% compared to the corresponding month of 2023.

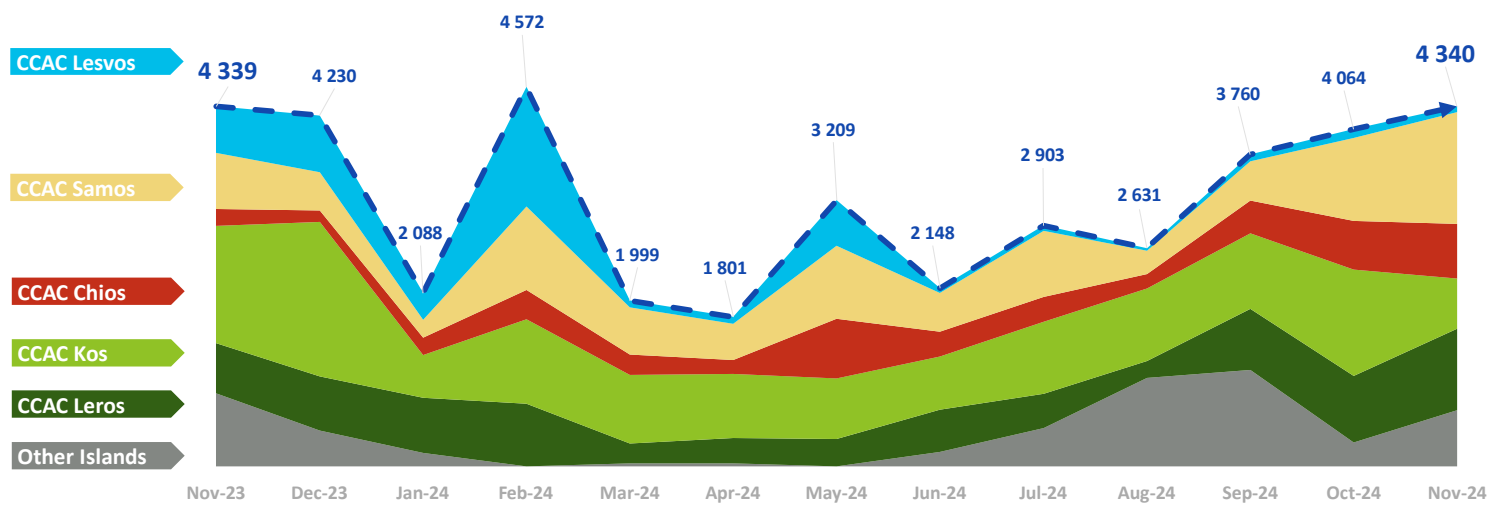


Chart 2. Transfers of asylum seekers from the islands to the mainland November 2023 – November 2024 - See Appendix Table 2

The residents in the islands decreased by 23% in November 2024 compared to the corresponding month of 2023.

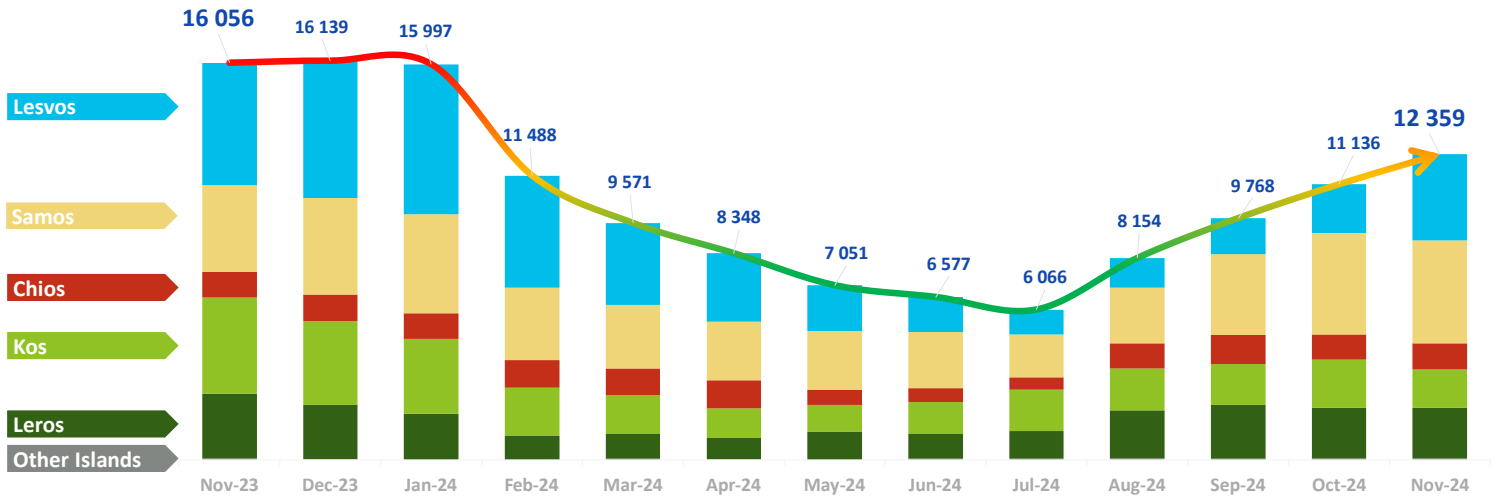


Chart 3. Island Residents in total November 2023 - November 2024 - See Appendix Table 3

The total number of residents decreased by 16% in November 2024 compared to the corresponding month of 2023.

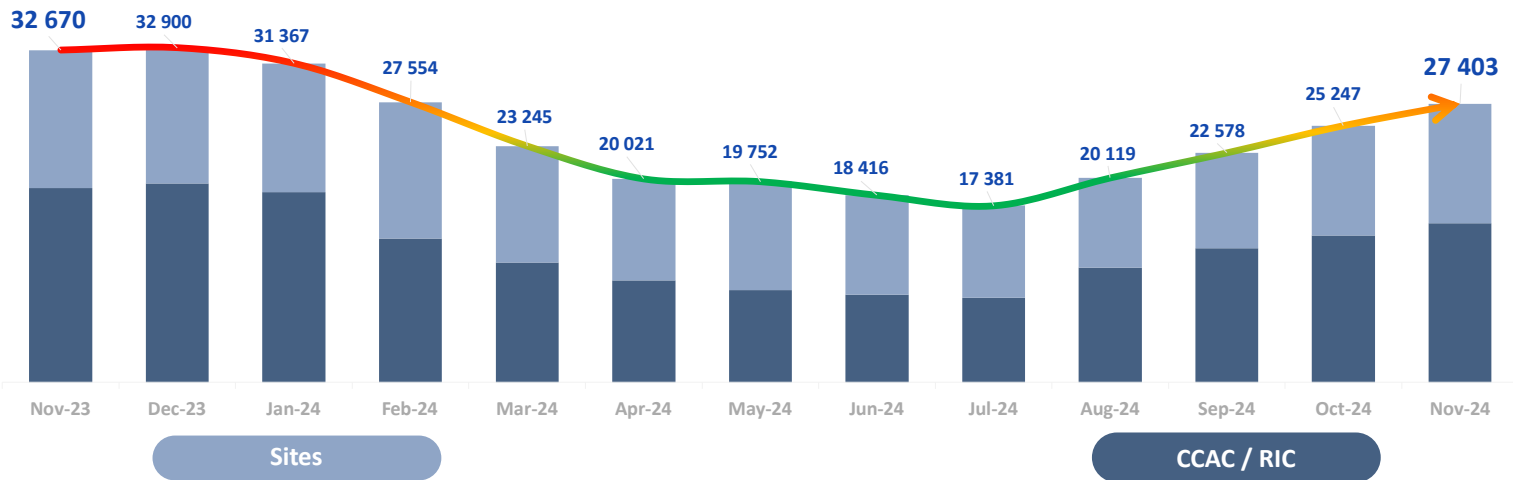
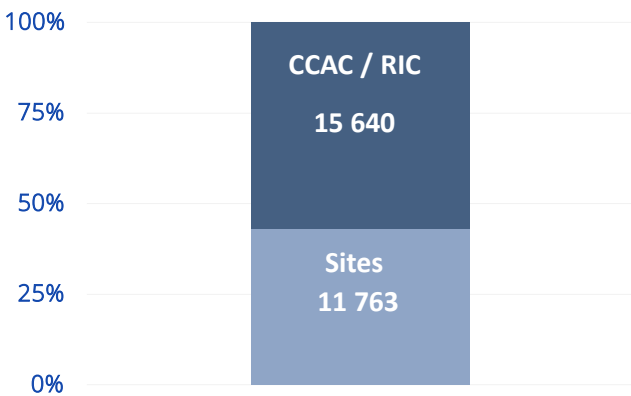
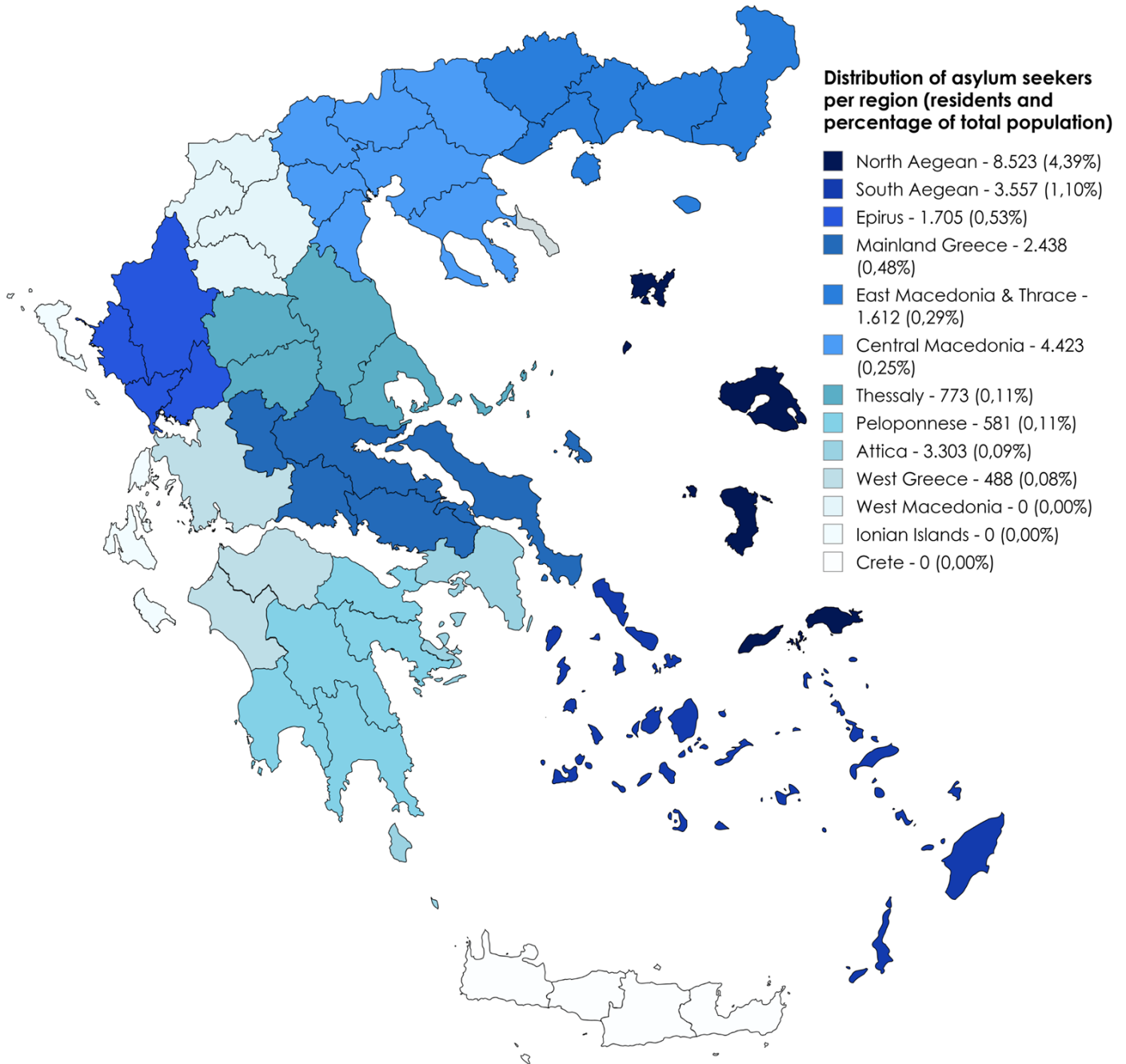


Chart 4. Progress of Residents through time – See Appendix Table 6

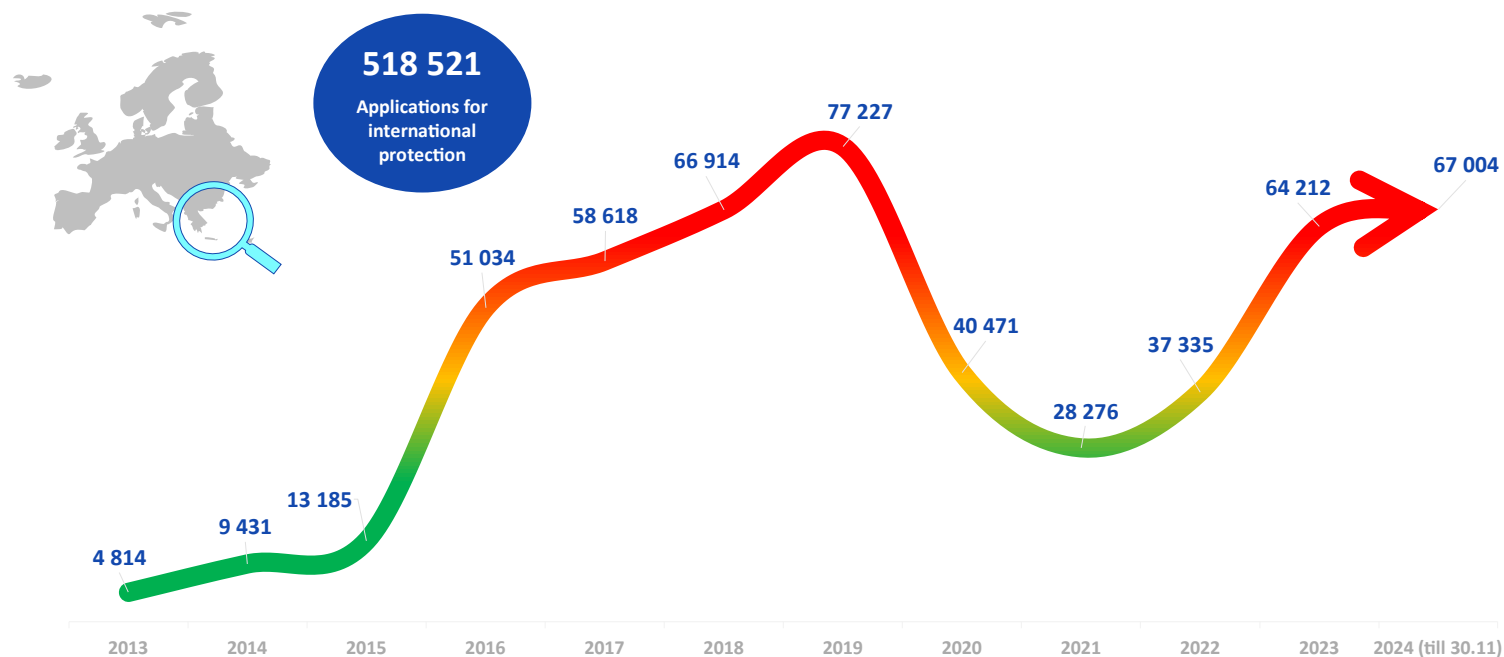


Chart 6. Applications for International Protection per year. For 2024 applications are calculated till the month of reference (November) - See Appendix Table 7a

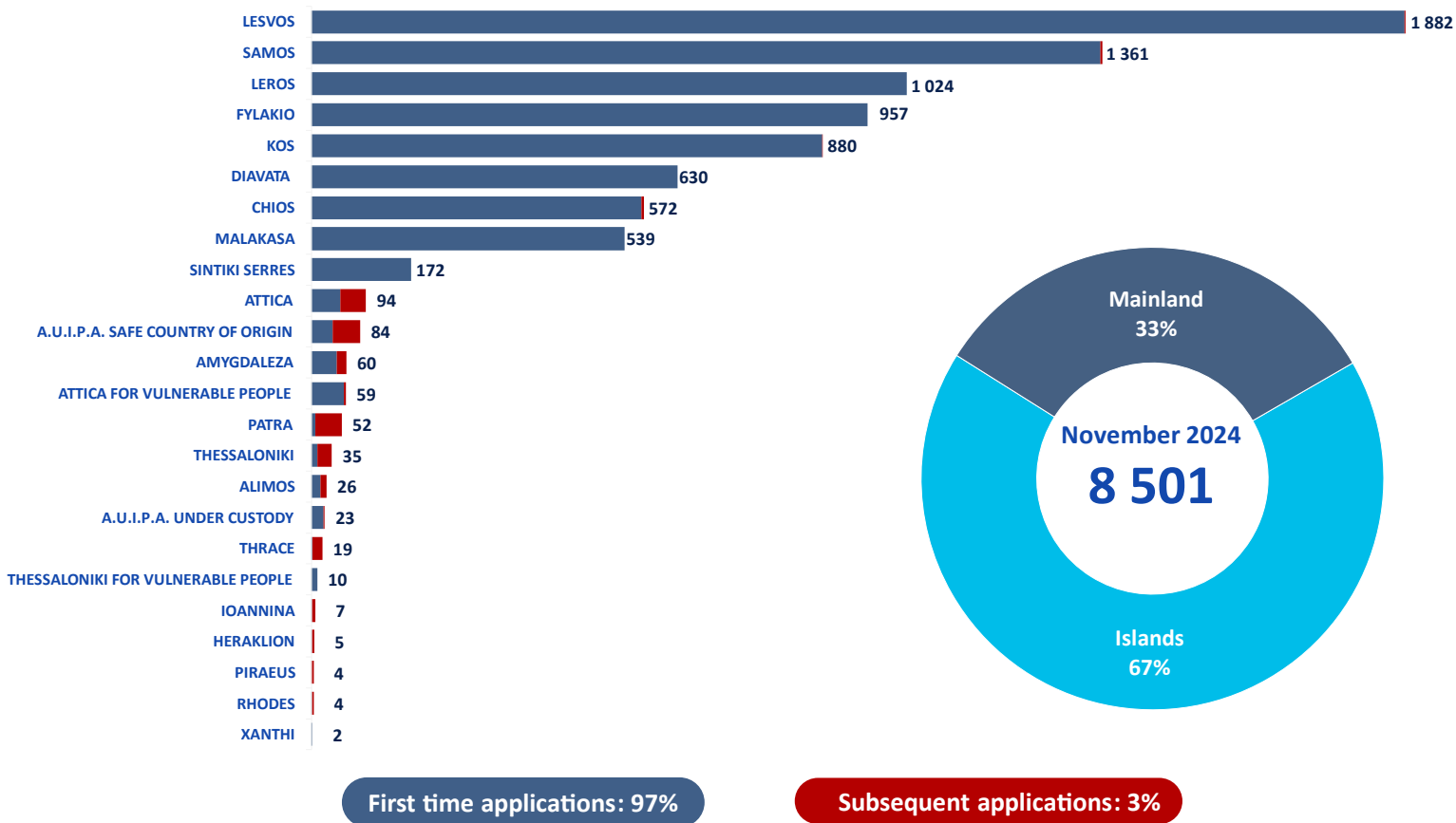

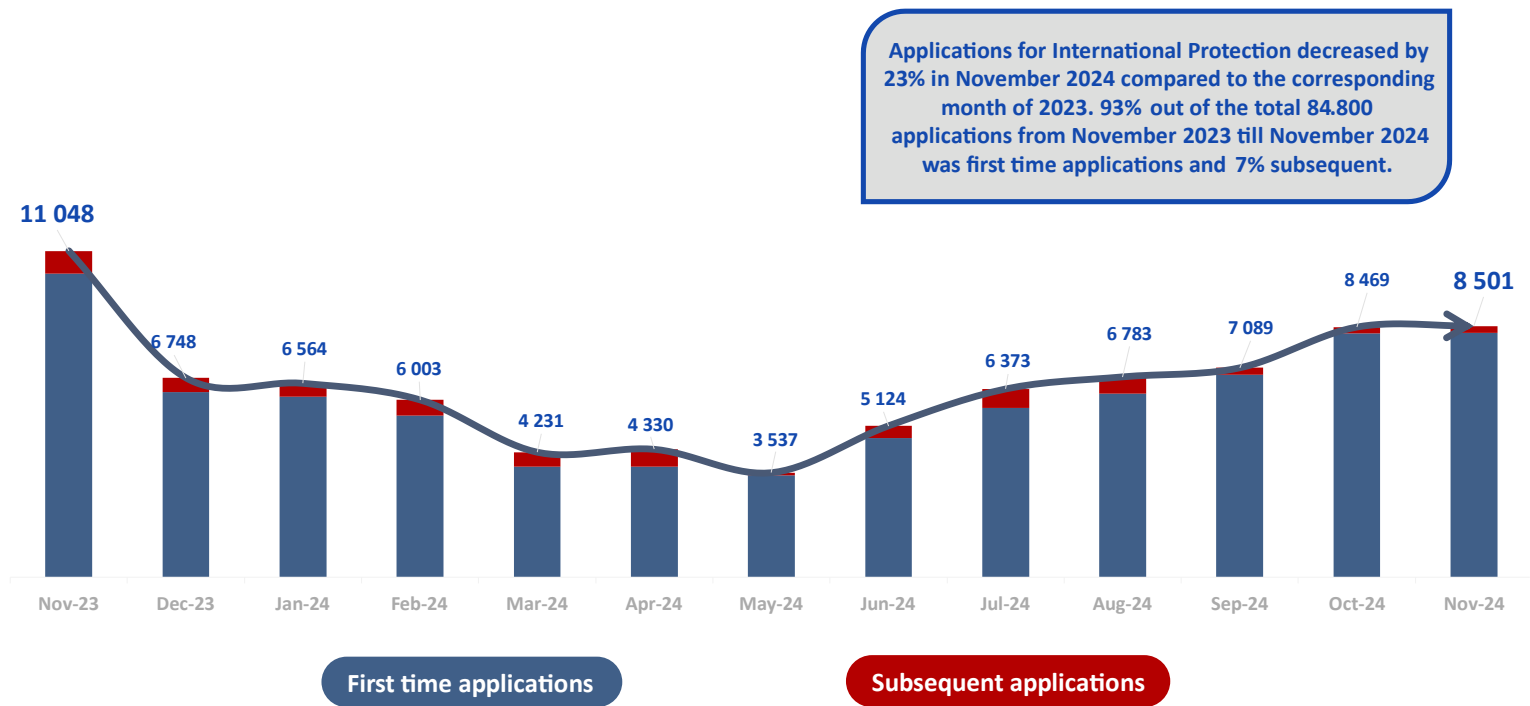


Chart 8. Applications for International Protection per month with distinction between first time and subsequent (November 2023 - November 2024) - See Appendix Table 7c

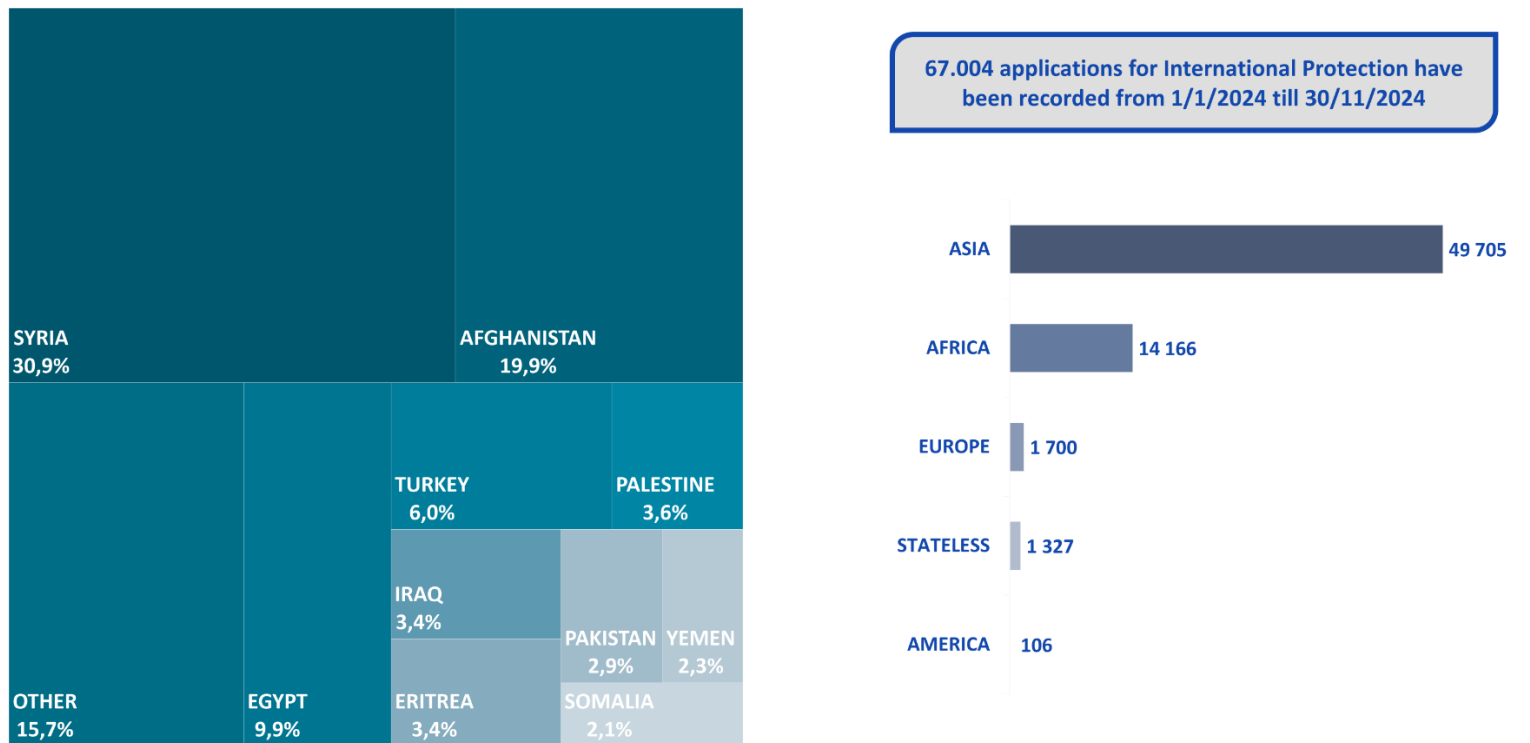


Chart 9. Applications for International Protection 11-months 2024 per Nationality (Top 10 Nationalities and distribution per continent) - See Appendix Table 7d

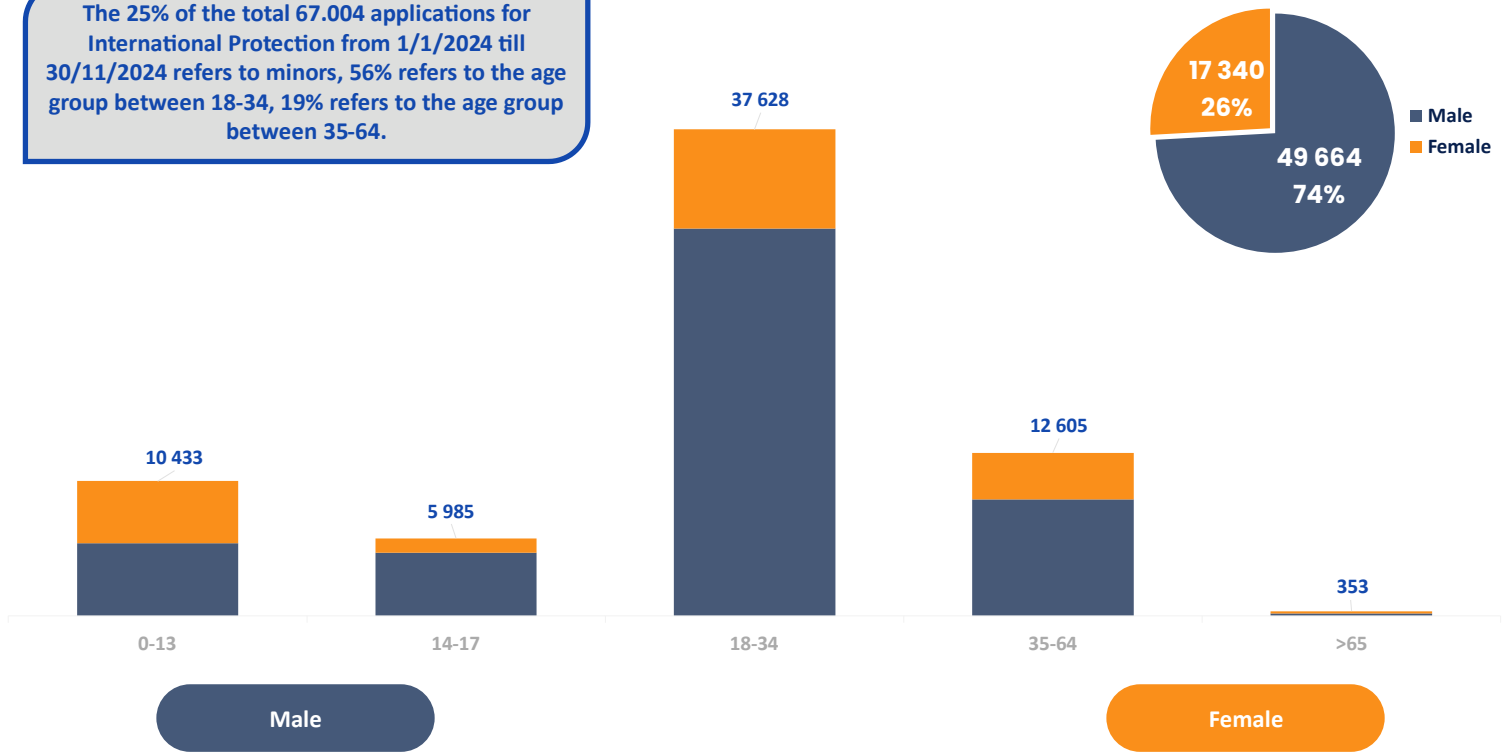


Chart 10. Applications for International Protection 11-months 2024 per gender and age group - See Appendix Table 7e

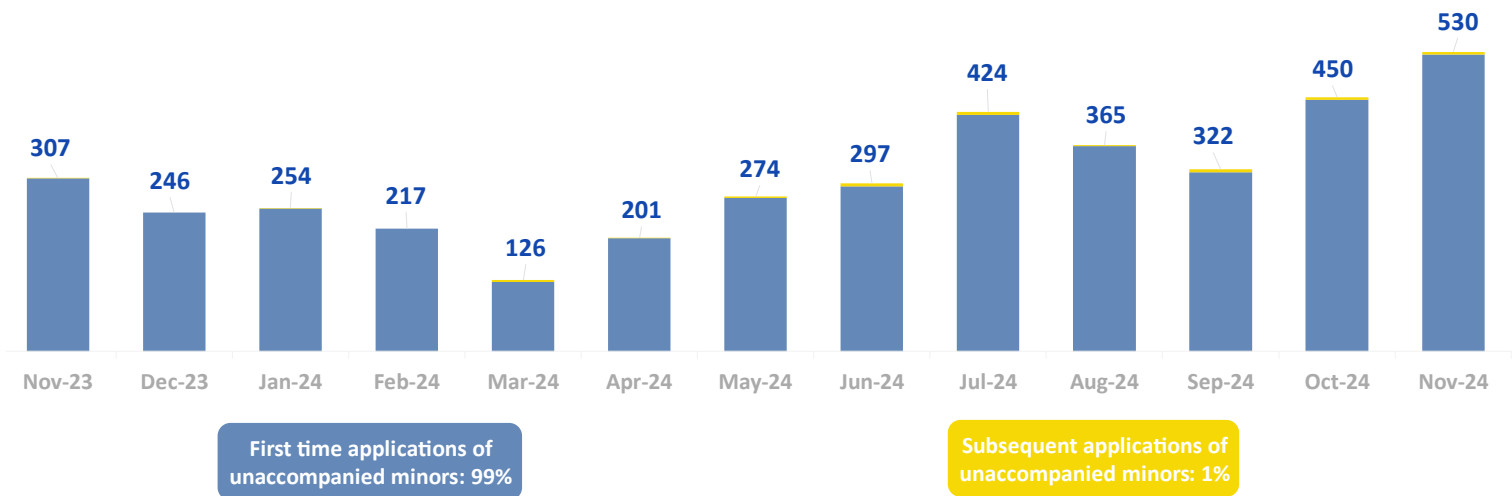
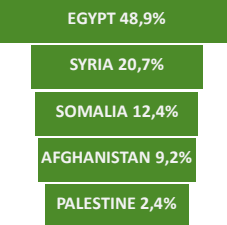
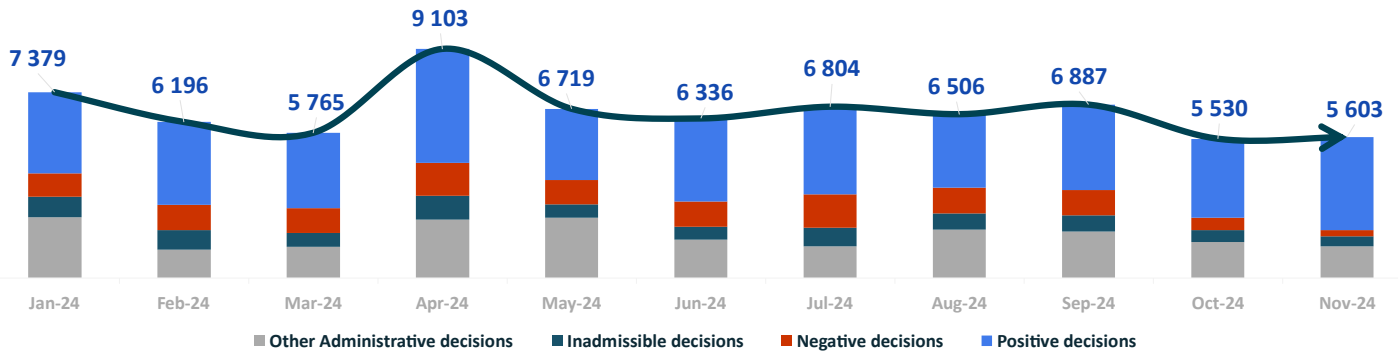
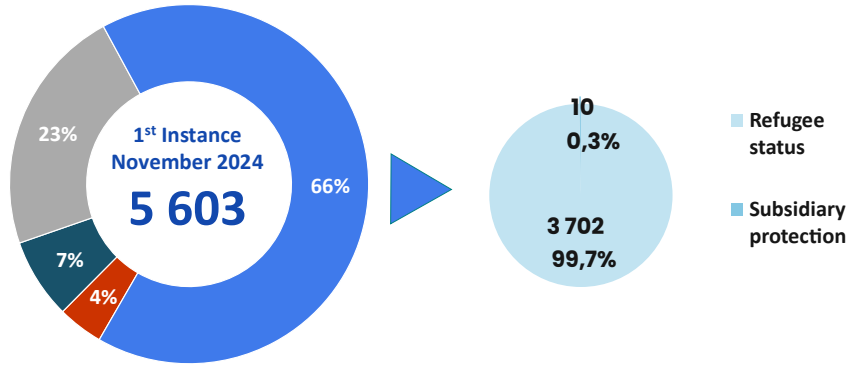

## 6a. Type of Decisions – 1<sup>st</sup> Instance

72.828 decisions have been issued in the 1<sup>st</sup> Instance from 1/1/2024 till 30/11/2024. 50,5% of them are positive, 23,8% negative and 25,7% refer to other administrative decisions.

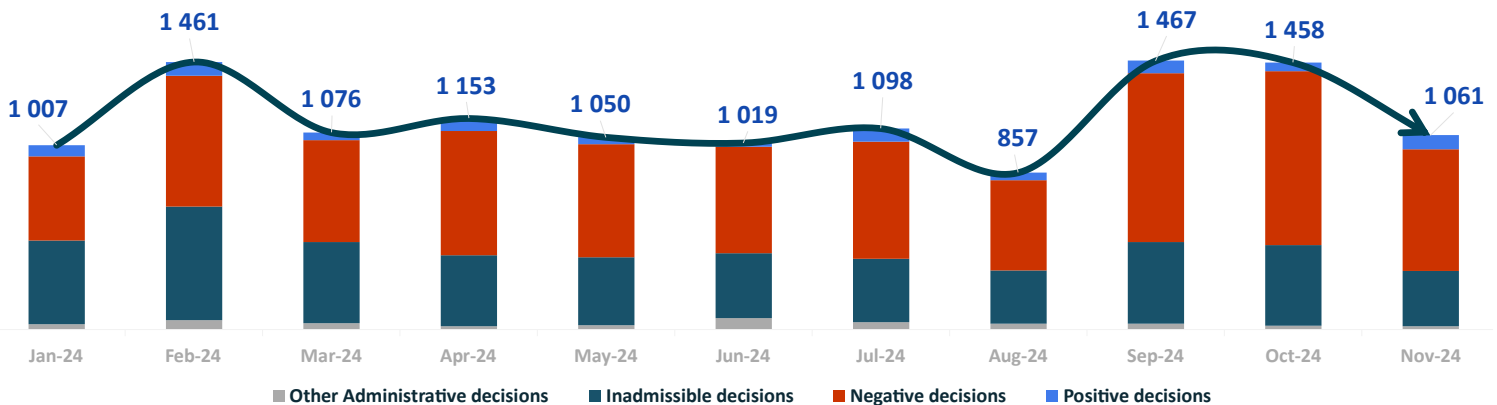
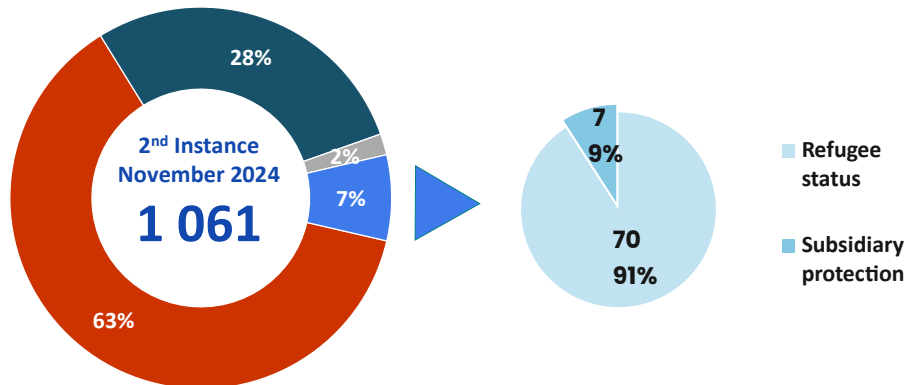


Chart 13. 2<sup>nd</sup> Instance Decisions per month and type for 2024 and for the month of reference (November 2024). - See Appendix Table 8b

Appeals in the 11-months of 2024 increased by 22% compared to the 11-months of 2023.

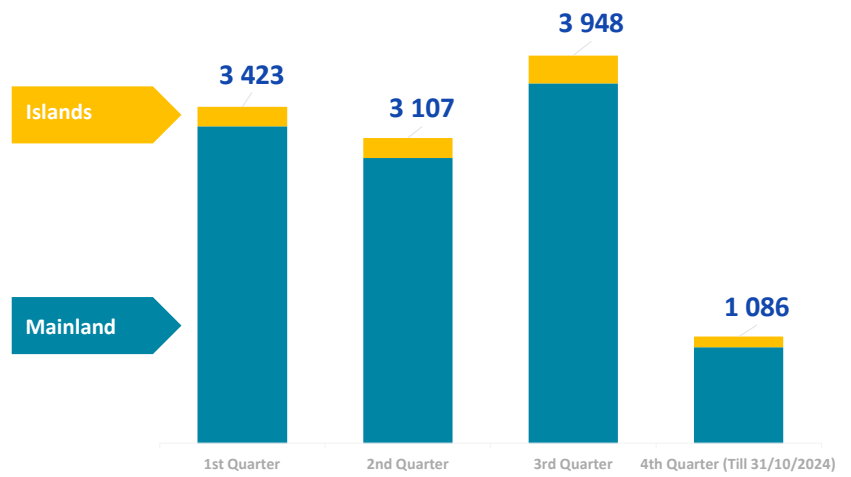
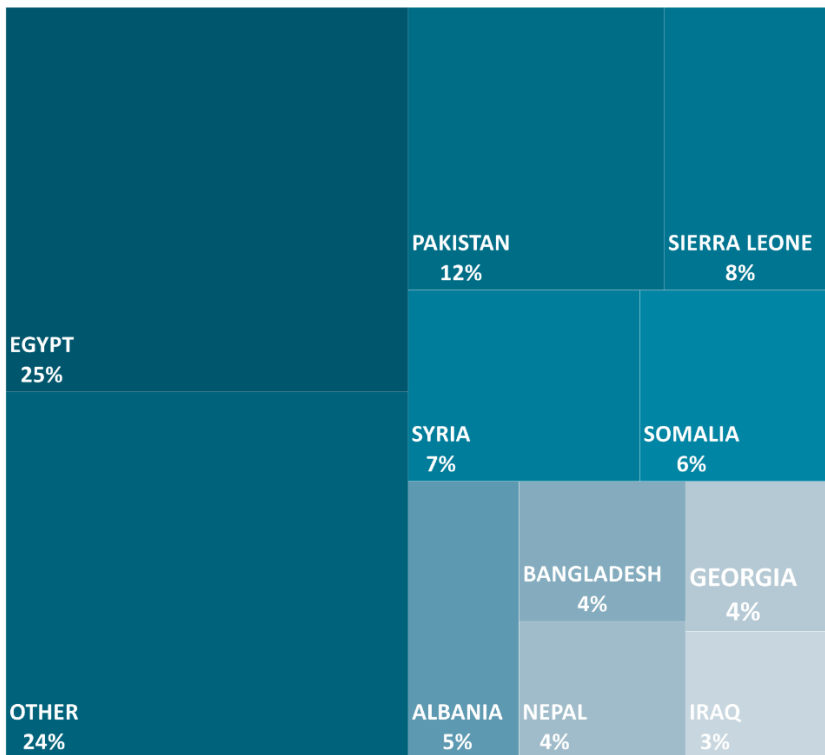


Chart 14. Appeals that have been lodged the 11-months of 2024 per location and quarter – See Appendix Table 9a



11,564 appeals have been lodged from 1/1/2024 till 30/11/2024.

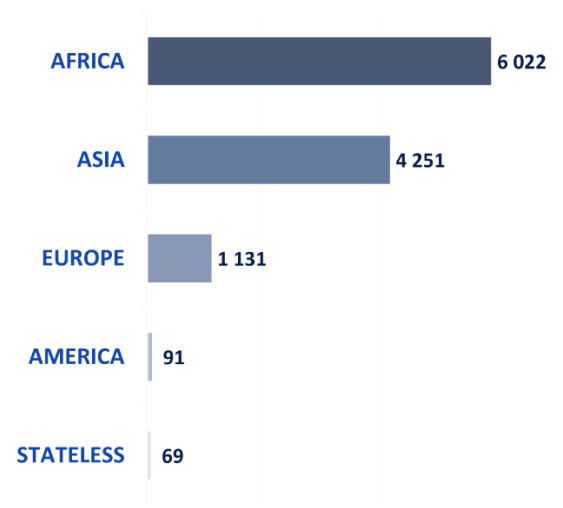

8a. Pending Pre-Registrations of applications for International Protection – Decisions issued in 1<sup>st</sup> and 2<sup>nd</sup> Instance

The total backlog (pending applications and decisions) decreased by 14% in November 2024 compared to the corresponding month of 2023.

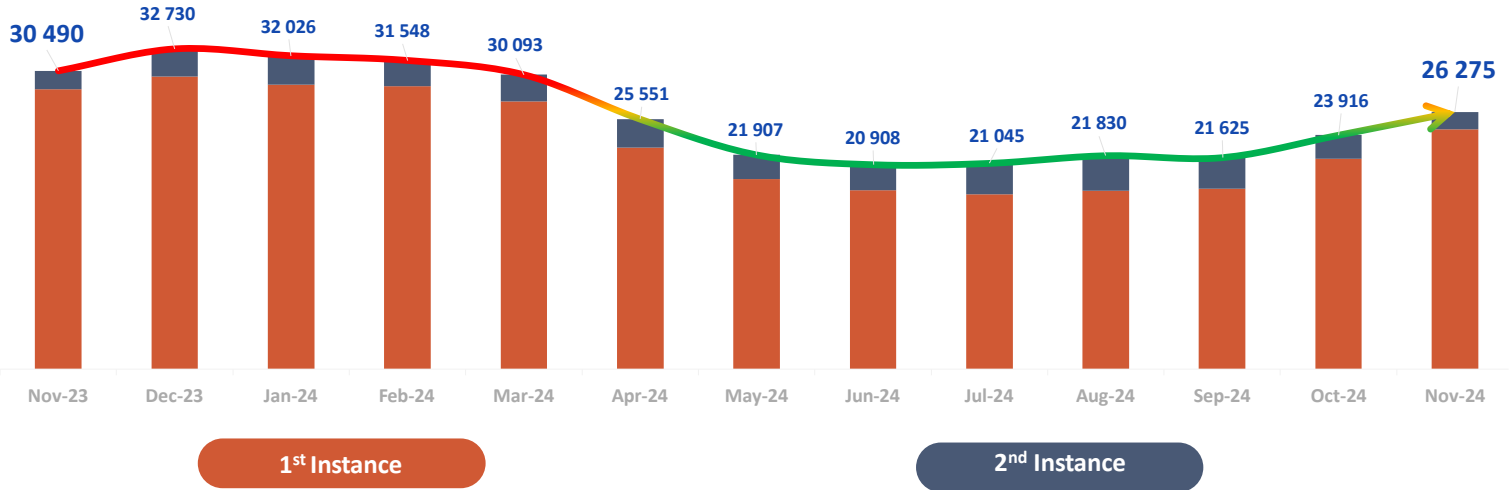

A comparison between November 2024 and November 2023 shows that the 1<sup>st</sup> and 2<sup>nd</sup> instance decisions have been decreased by 23%

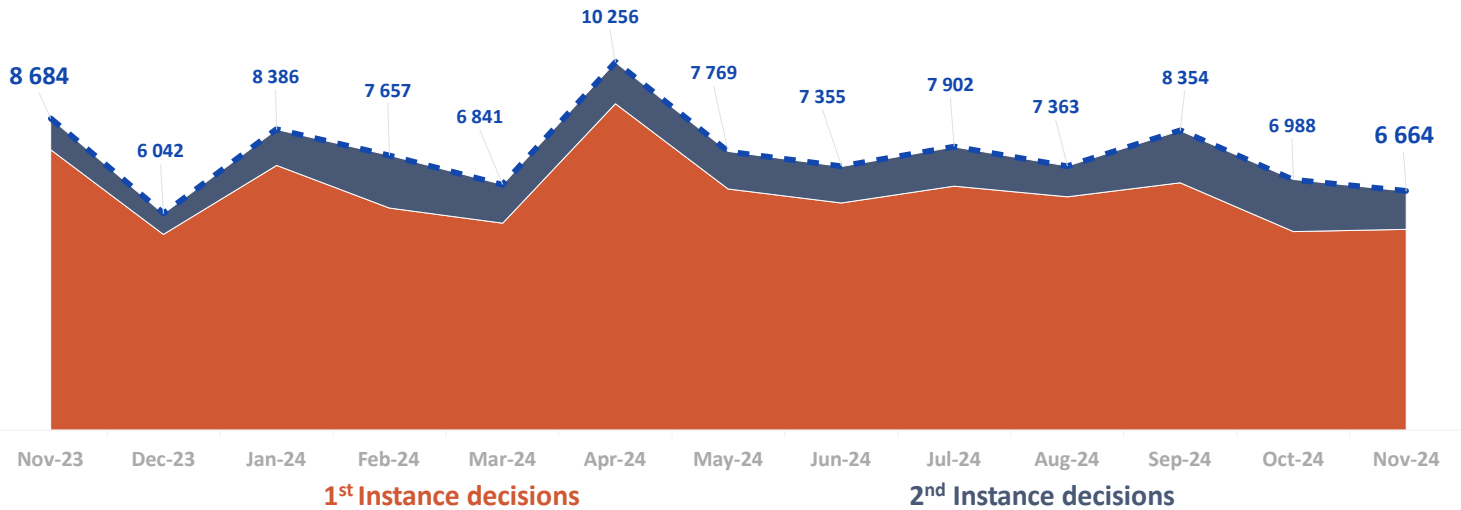


Chart 17. Aggregate Decisions issued in 1<sup>st</sup> and 2<sup>nd</sup> Instance per month - See Appendix Table 10a

- The average time for a 2<sup>nd</sup> Instance decision to be issued is 89 days since the date of appeal lodging, while it is 51 days from the date of appeal discussion.
- The total of pending decisions of Appeals Authority (1.759 pending) consists of cases that have been discussed till November 2024 (1.262 pending) or are scheduled to be discussed after November 2024 (497 pending).

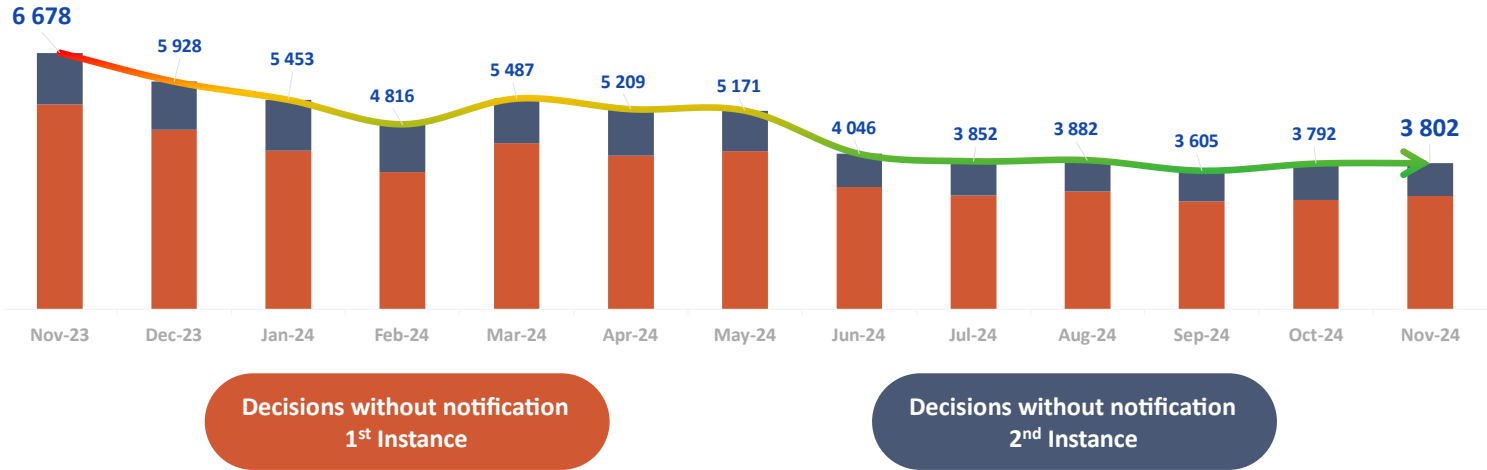

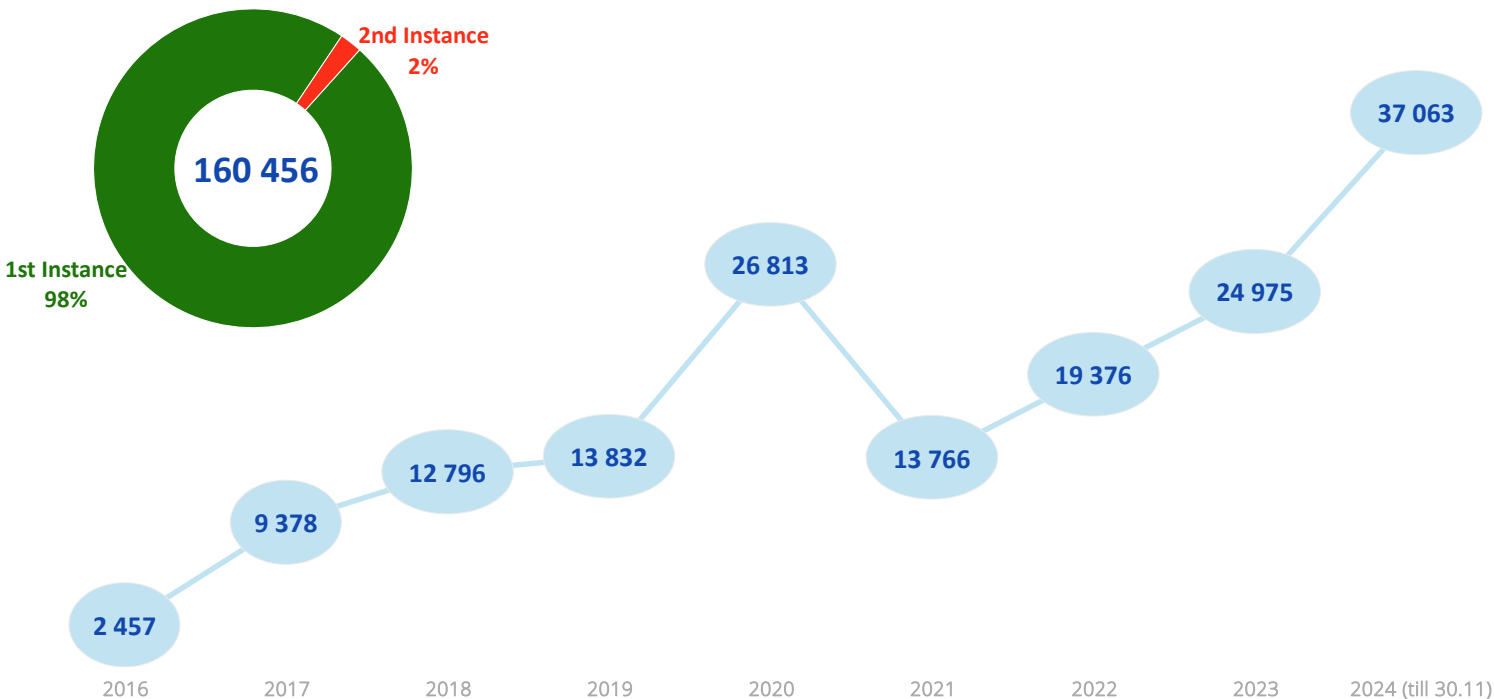

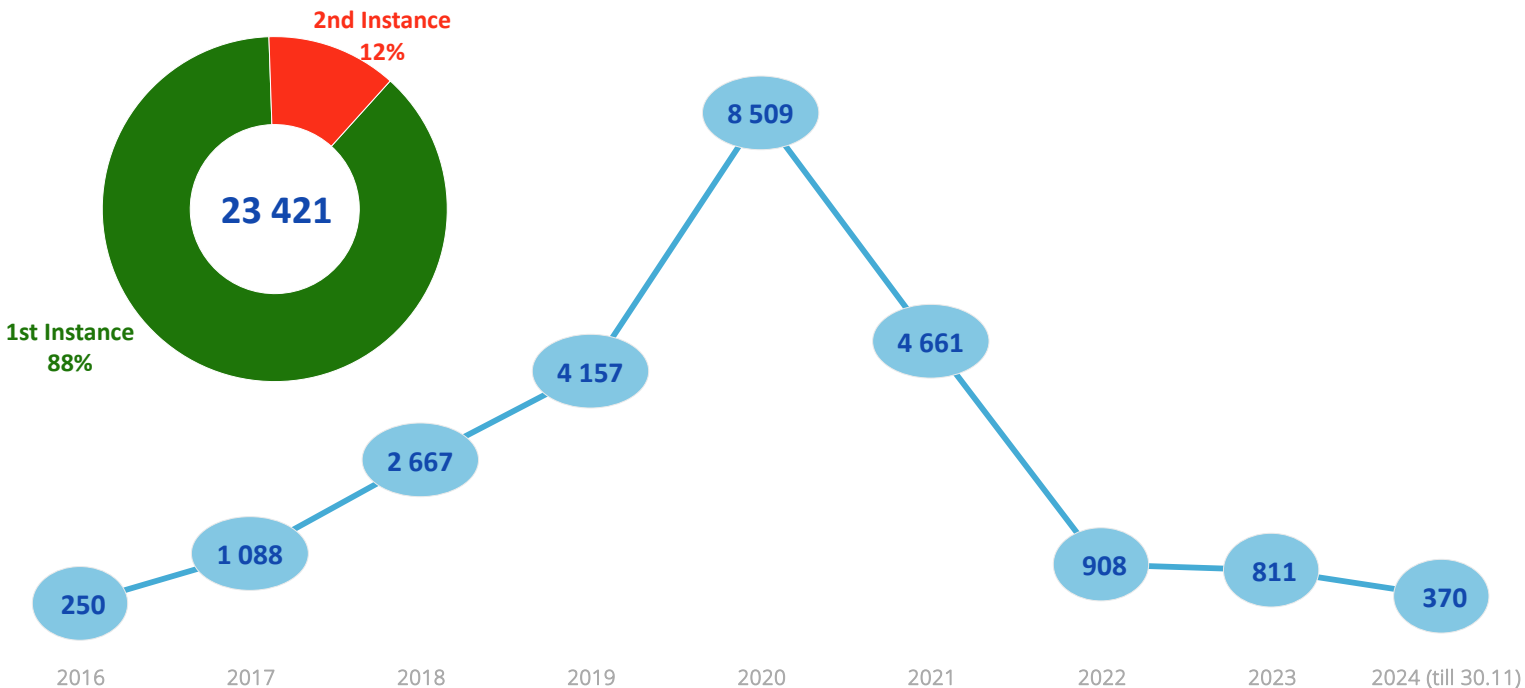
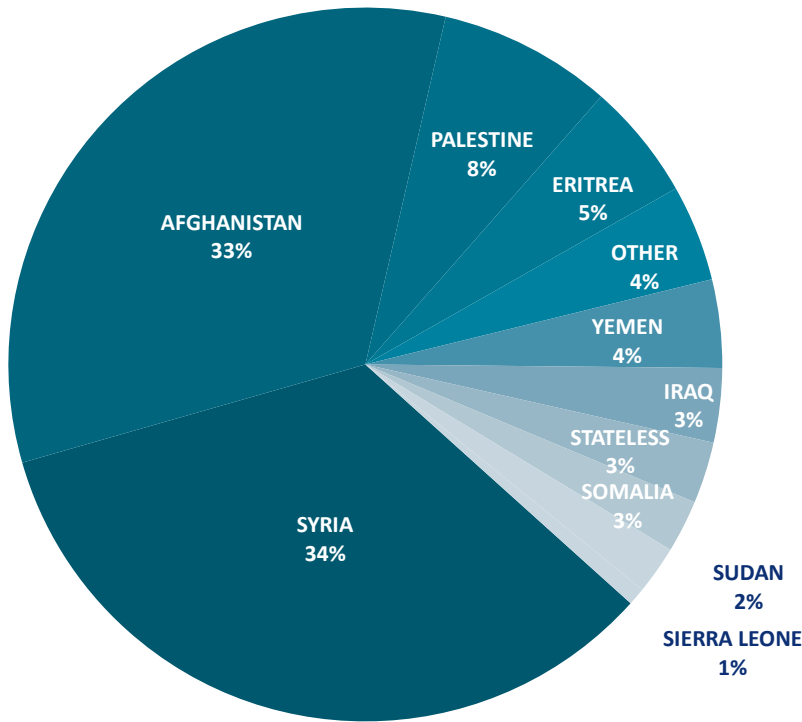

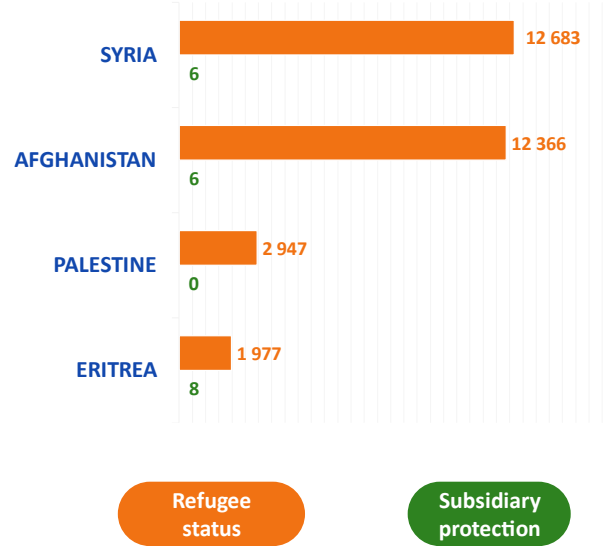

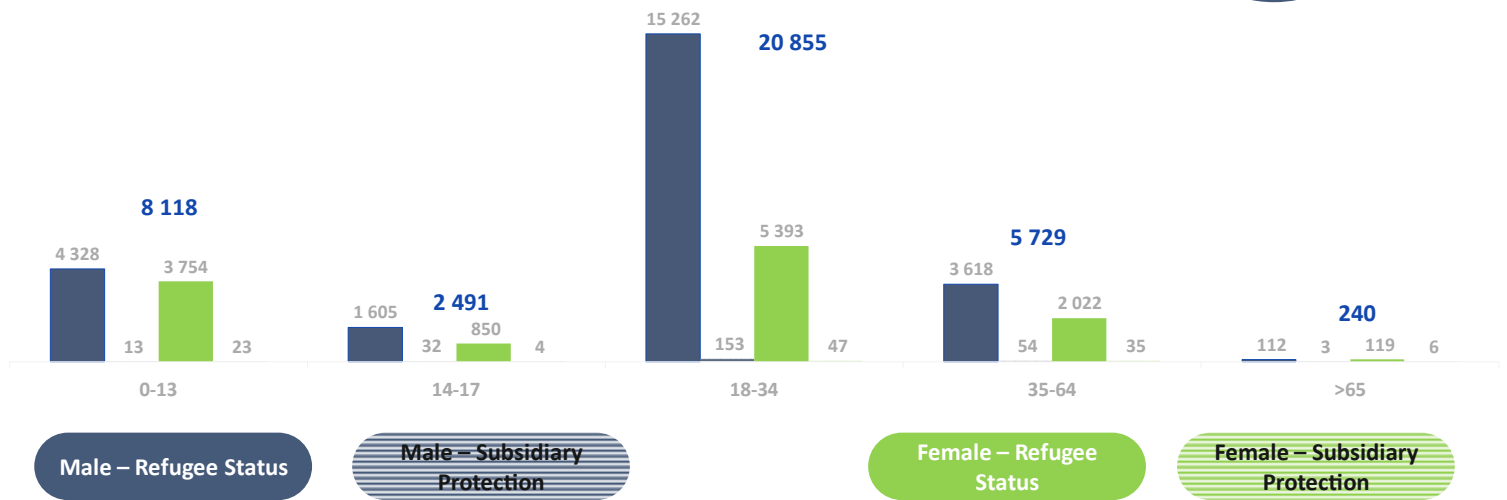
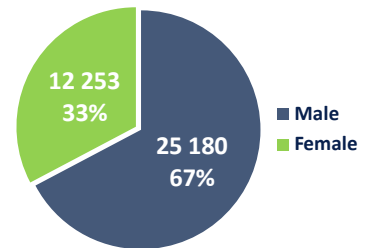

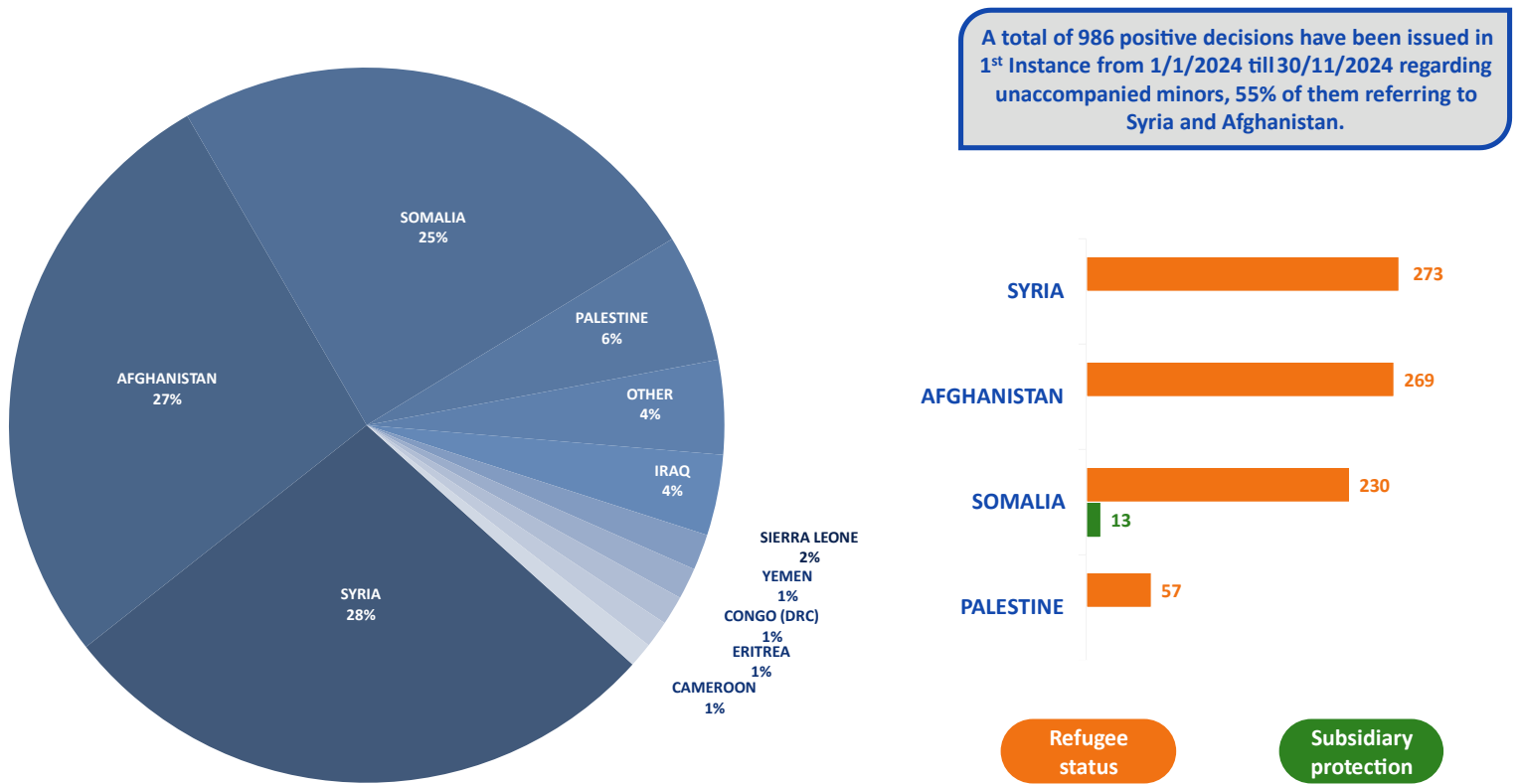

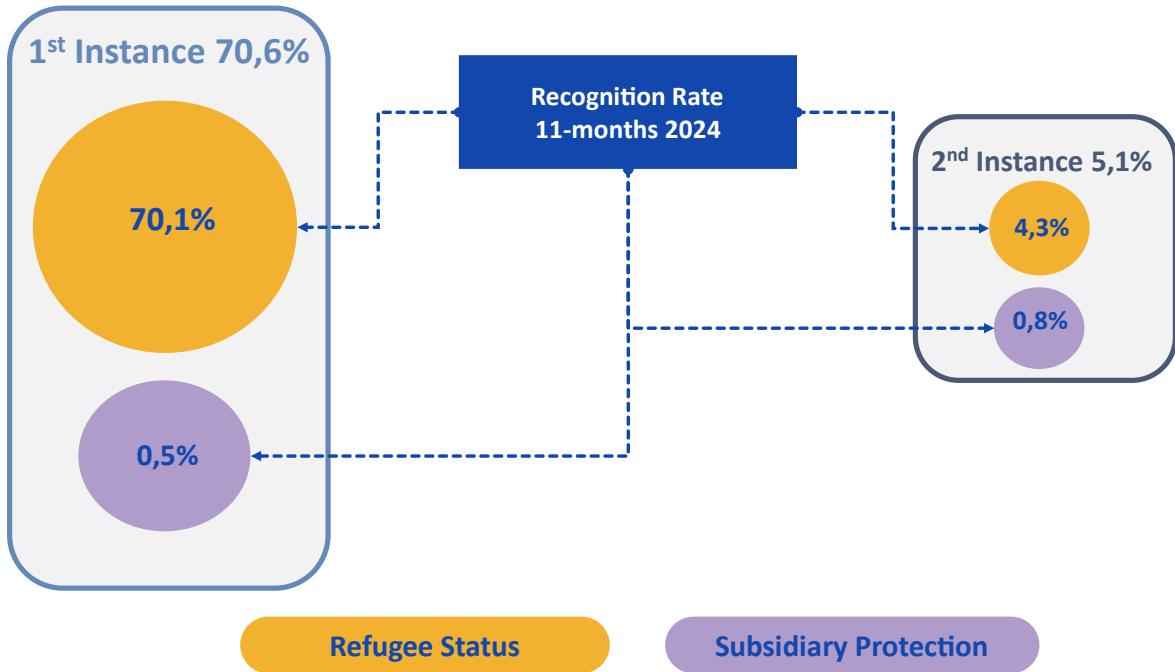


Chart 25. Recognition Rate in 1<sup>st</sup> & 2<sup>nd</sup> Instance. See Appendix Table 11g

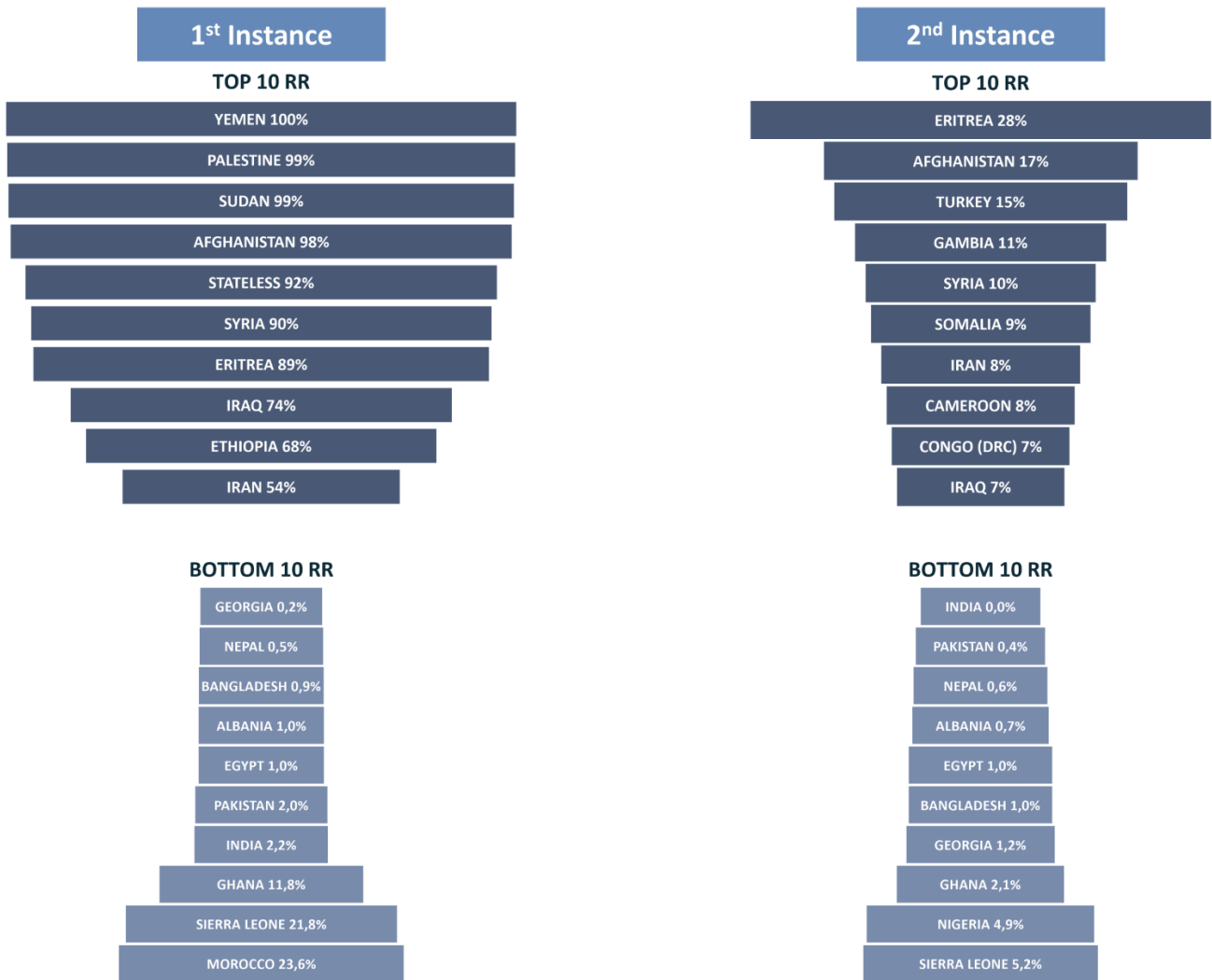

## 10. Applications for annulment of 2<sup>nd</sup> Instance Decisions before the Administrative Court

The 23,5% of the total applications for annulment per year of lodging (6.210) are pending while for the rest of them (76,5%), a decision has been issued. 4,5% of the decisions had a positive outcome and 95,5% were rejected.

From the total of 4.748 decisions regarding applications for annulment (per year of decision) 58% have been issued in 2022, 2023 and 2024.

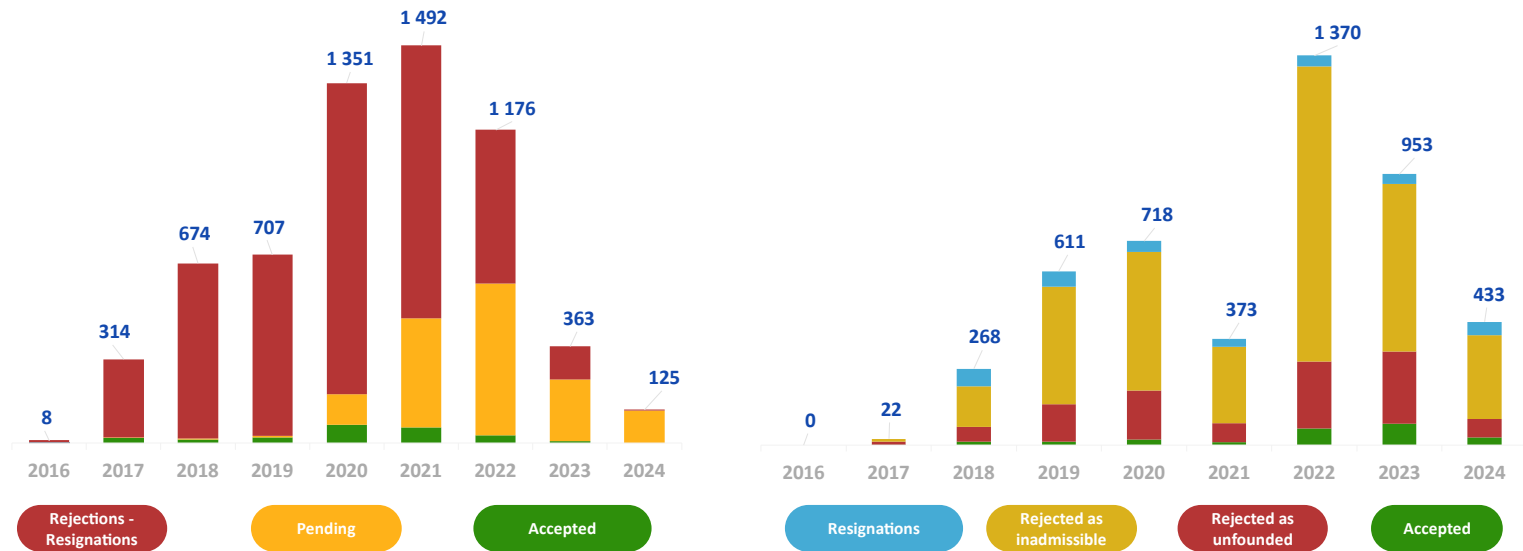

## 11. HELIOS Integration Program

The "Helios" program is funded by the European Union. Its purpose is to promote integration support for beneficiaries of International Protection and is implemented with:

- accommodation support
- through integration courses (learning the Greek language, enhancing social skills)
- Job counselling sessions
- raising awareness of the host Community and promoting social cohesion.

The Ministry of Immigration and Asylum monitors the implementation of the program, which is implemented by the International Organization for Migration. From 16/7/2019 until 30/11/2024 47.753 people have registered in the program (\*data regarding the enrollments are up to 31/8/2024), while 24.509 recognized refugees receive financial assistance for renting a house (\*data regarding house renting are up to 31/10/2024). It is worth noting that in October 2024, 3 new leases were added to the accommodation support of the "Helios" program (regarding the period from 1/10/2024 till 31/10/2024). At the same time 10.659 beneficiaries of International Protection have been enrolled in the integration courses and 12.693 people are attending job counselling sessions.

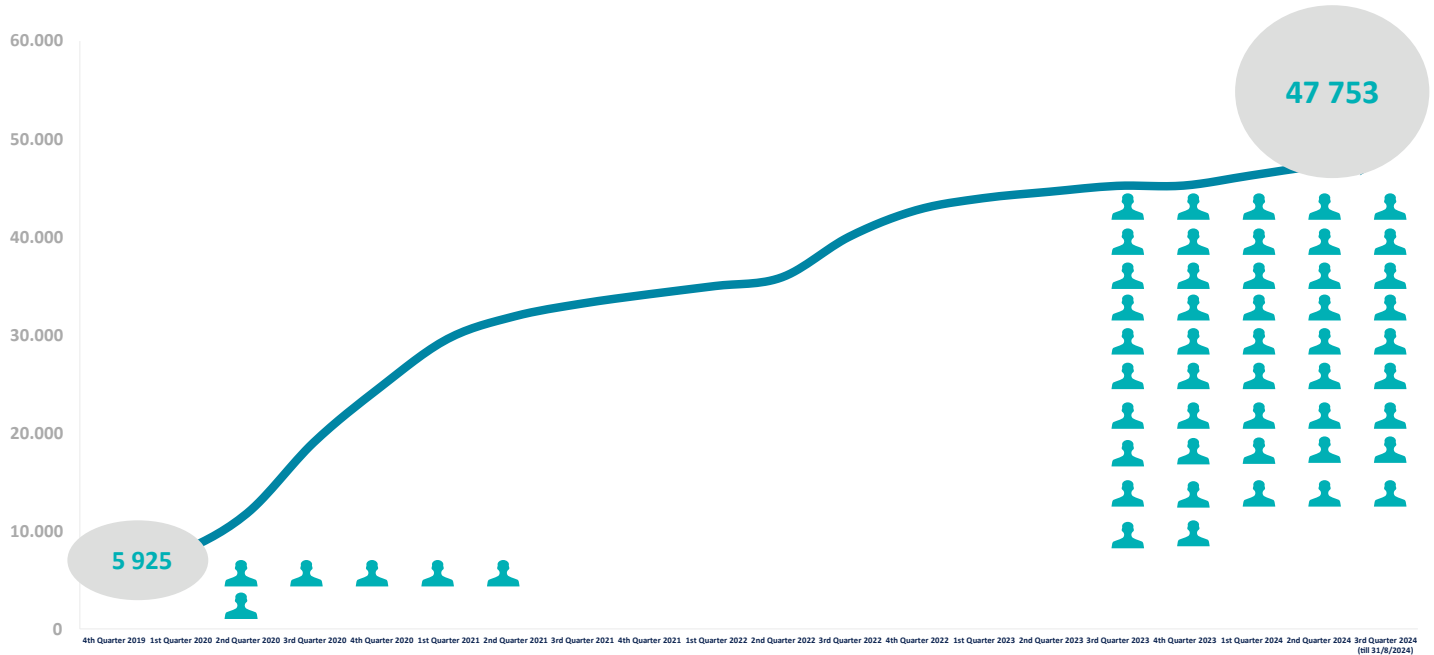


Chart 28. Helios Enrollments – See Appendix Table 13

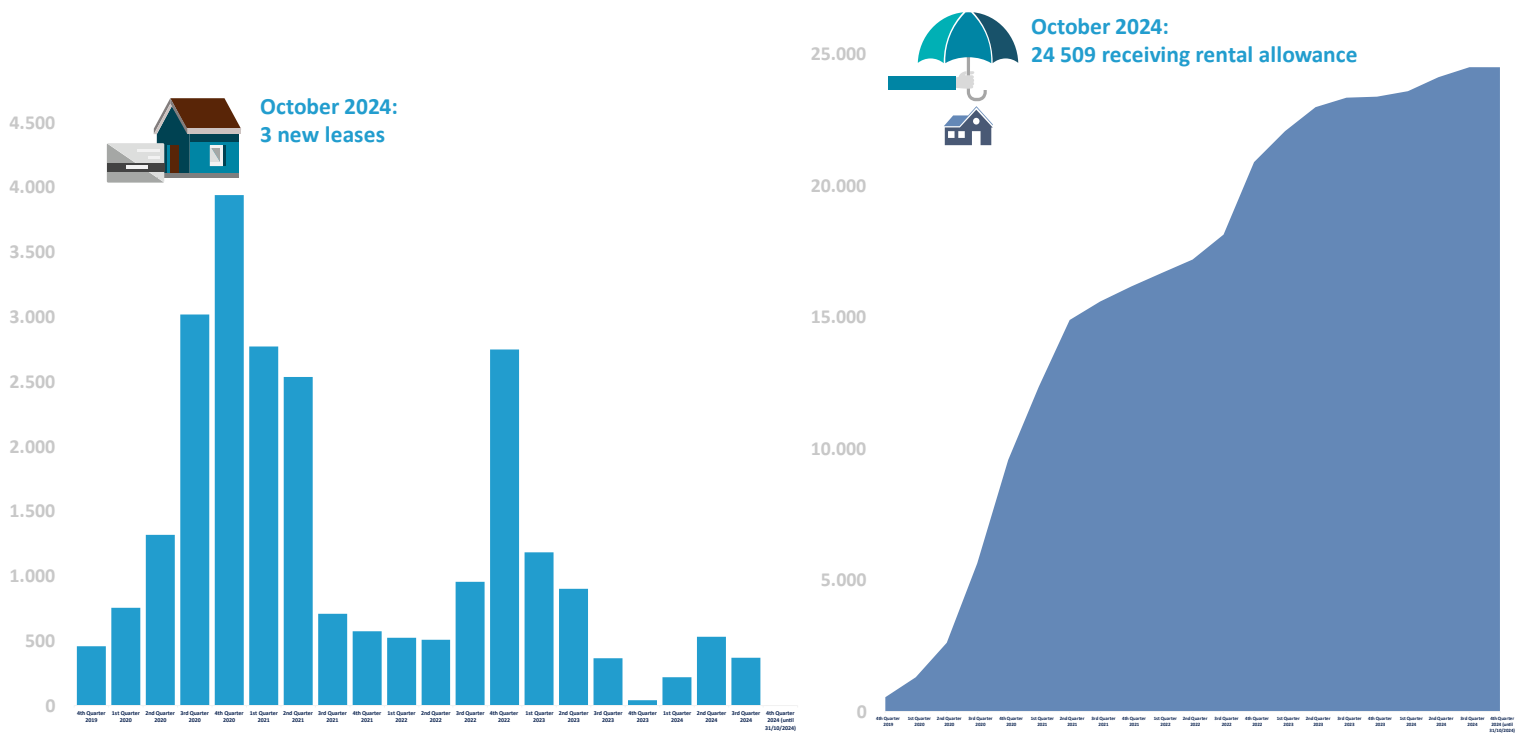


Chart 29. New leases (left), Receiving rental allowance (Right) - See Appendix Table 14 and 15

## 12. Returns - Departures

In November 2024 the departures from Greece to third countries outside the EU, as well as to member states of the European Union are the following:

- 187 forced deportations and returns of third country nationals, based on agreements of the European Union, but also bilateral agreements of our country.
- 285 voluntary departures through IOM.
- 122 voluntary departures of immigrants from our country to their countries of origin.
- 53 transfers to Member States of the European Union under the Dublin Regulation.
- 156 people seeking International Protection were transferred to France (150) and Iceland (6) in the context of voluntarily relocation program.
- Returns under the EU - Turkey Joint Declaration have not been made since March 2020 due to Covid-19. It should be noted that despite the lifting of the Covid-19 measures the requests of missions-returns of the Greek authorities have not been answered.
- A total of 803 people left the country in November, while 7.105 arrived.

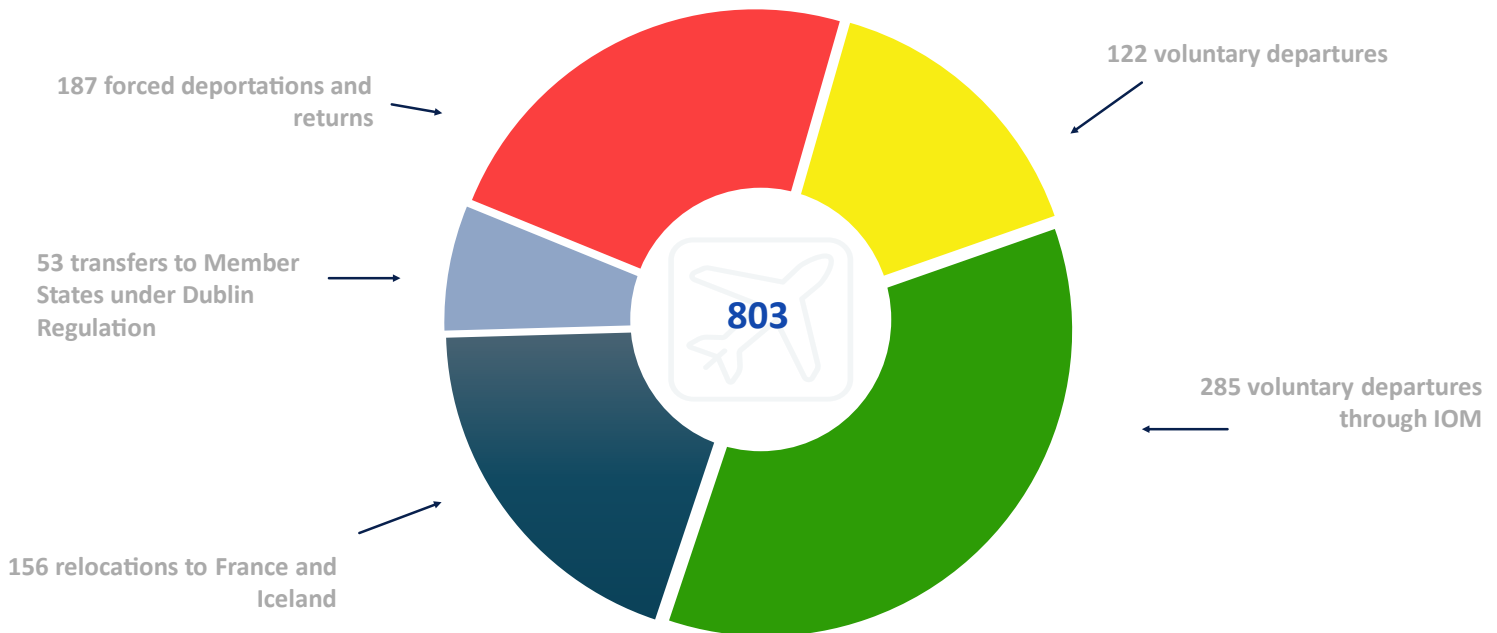


Chart 30. Returns-Departures – See Appendix Table 16.

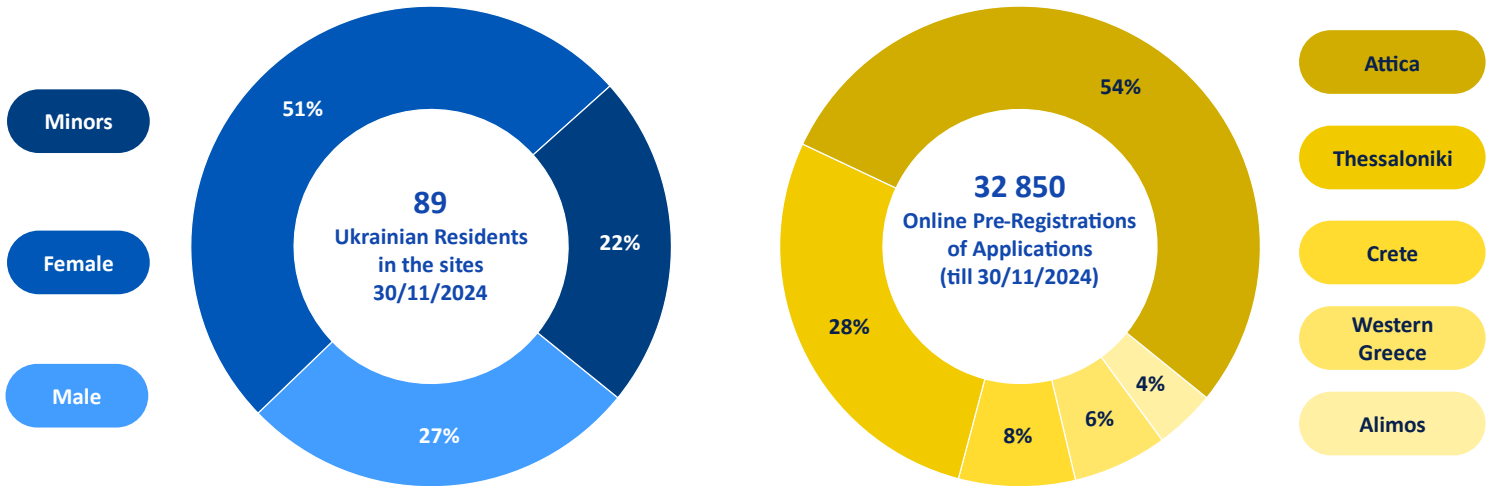


Chart 31. Total Ukrainian Residents & Online pre-registrations of applications (November 2024) - See Appendix Table 17 & 18

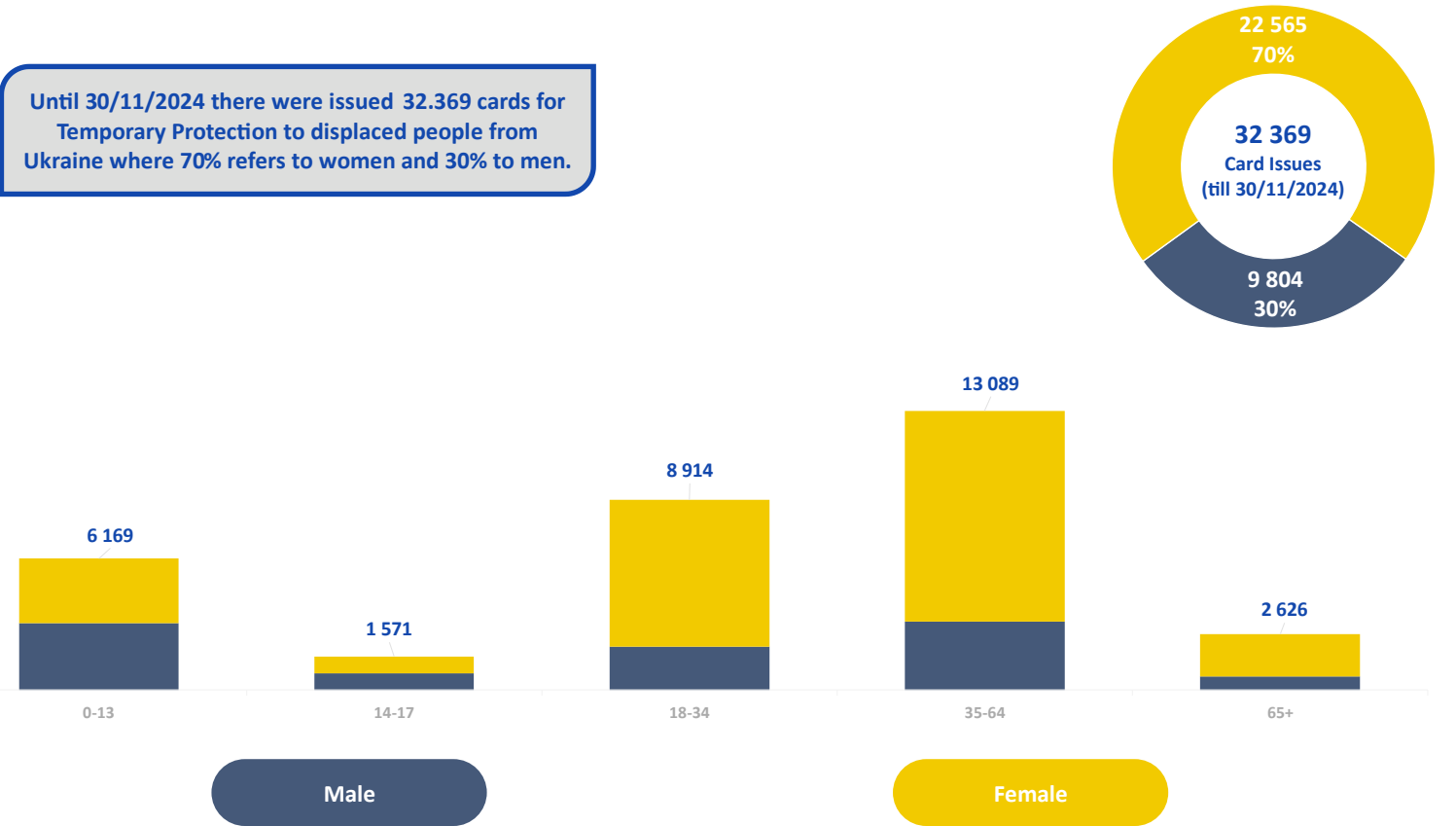


Chart 32. Total card issues to Ukrainians for Temporary Protection per age group and gender (November 2024) - See Appendix Table 19

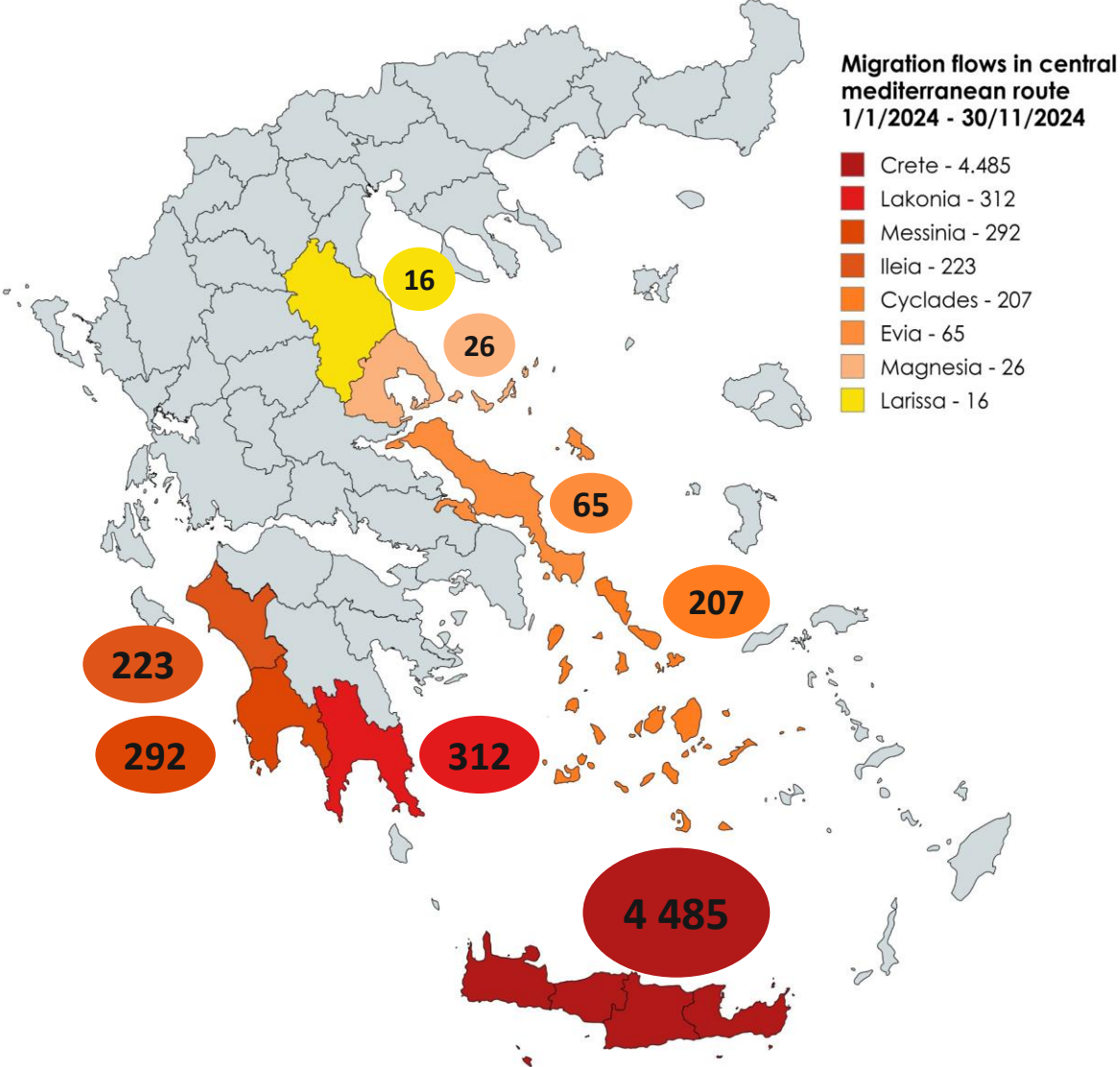


Chart 33. Migration flows in central mediterranean route (1/1/2024-30/11/2024) - See Appendix Table 20
