



## **UAM** analysis per accommodation type



The National Emergency Response Mechanism for Unaccompanied Minors (UAM) in precarious living conditions launched the telephone line in April 2021. Until today, the Mechanism received 13.670 calls, which concern 10.037 different cases of (UAMs), out of which 8.230 concern accommodation requests, 1.127 legal aid, and 680 other types of assistance. Since 02.03.2022, the line has received referrals for 4 unaccompanied\*, 10 orphans (with escorts) directly from an orphanage of Ukraine and 591 separated minors from Ukraine.

\*there are cases of unaccompanied minors whose status changes from unaccompanied to separated following their initial referral as well as due to their adulthood
