TO FIND MORE INFORMATION ABOUT THE BIA, YOU MAY ASK:

- Your Guardian.
- > The person responsible for you, when living in an accommodation facility.
 - > The team of professionals who care for you, in any other case.





You actively participate in the process. You can speak your mind and ASK WHAT YOU WANT OR NEED. Adults listen and take it seriously.

Your personal information is valuable.
WE DO NOT DISCUSS WITH OTHERS WHAT YOU
SHARE during your best interests assessment.

We may give others SOME INFORMATION ABOUT YOU,
WHEN IT IS NECESSARY FOR THEM TO HELP YOU, such as
when visiting the doctor's office or enrolling at school.
Before we share any information, we will make sure to let
you know.

If there is a danger in your life
or if someone is hurting you, then we must share
information with others to MAKE SURE THAT
YOU ARE SAFE AND SUPPORTED. In this case, we will also
make sure you know.

All information about you is found in one file that ONLY YOUR GUARDIAN AND THE TEAM OF PROFESSIONALS WHO CARE FOR YOU MAY SEE. You can see your file, whenever you want.





















The Best Interests Assessment is a way to learn your needs and wishes and find together what is possible for you to do in Greece.

You and **Every professional** who is responsible for you and your care (such as the Social Worker where you live or your Guardian). Other important people in your life may participate if you wish.

With Questions and Discussion

Wherever you are in Greece, in every location you reside.

It begins **when you arrive** and is renewed as you grow up and for as long as you stay in Greece until you turn 18 years old.



- To give your opinion and be heard.
- To speak about your life in your country and your life in Greece.
- To say what you need, what you want and what you think about all things in your life.
- To share only once this information with the people who care for you.
- To look together for solutions to all things that affect you.
- To plan together the steps for these solutions.

ABOUT THE BEST INTERESTS ASSESSMENT (BIA)



- It is done for ALL CHILDREN found in Greece alone (without parents).
- It is done BEFORE EVERY IMPORTANT DECISION about your life.
- > Your GUARDIAN has access and participates.
- > We ask for your OPINION.
- > We ask for your FAMILY'S opinion, if you want.
- > We discuss and weigh ALL INFORMATION about you.
- > We set together a PLAN for your life.
- YOU also TAKE ACTIONS for yourself.
- The assessment of your best interests CHANGES with time, because your needs and wants change as you grow up.
